Maire Mhic Uidhir thanked the Chairman and outlined the activities of the group to date and also their aspirations for the future. She also stated that a report would be prepared and submitted to An Coiste Gaeilge Gaeltachta in due

Irish Signs in the Regional and Merlin Park Hospitals Members expressed their disappointment at the lack of bilingual signs at the above locations and requested that the matter be taken up with the hospital authorities together with the need for a working knowledge of Irish by medical and other staff.

Temporary Road Work Signs Members welcomed the provision of temporary Road Work Signs in Irish by the County Council. Senator o Cuiv wanted to know why bilingual signs are not available in the whole county, as it was his opinion that this was already agreed to by an Coiste. The County Secretary stated an Coiste's concern was that such would be erected in Gaeltacht areas, however, he agreed to have the matter examined.

Accommodation would be available at either Carraroe Hotel or the Connemara Coast Hotel. Peadar Mac Flannacha requested that the Council provide financial assistance.

The County Manager said that the Government had made a decision to set up County Enterprise Partnership Boards in each County. In the formation of the Boards, it had been decided to amalgamate the County Development Teams and Regional Tourism Organisations. He said that the membership of the Galway County and City Enterprise Partnership Board would consist of 18 people as set out on page 8 of the Appendix. The Partnership Boards would have three key objectives -

- (a) Development of small and start-up Enterprises employing up to 12 people.
- (b) Training and education.
- (c) Local community development.

He said that a number of questions had to be answered yet in regard to staffing, etc.

While the Chairman and Members welcomed the setting up of the Boards, some concern was expressed at the small local authority representation. Councillor Walsh said that emphasis would need to be placed on the maintenance of jobs as distinct from the creation of jobs, and he mentioned increases in rateable valuation of small commercial properties as unhelpful.

### RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT (AMENDMENT) ACT, 1955 - PLANNING APPLICATION NUMBER 66737 - APPLICANT: LIAM CREAVEN.

Senator O'Cuiv proposed the resolution set out on the Agenda. He said that the planning history of the site was relevent and referred to the fact that in 1981, Outline Permission was granted on the site, and this was followed subsequently by an Approval to Mr. Creaven. He said the applicant bought the site on the basis that Planning Permission existed with no Enurement Clause. The Permission had run out and the applicant had now re-applied. Senator O'Cuiv said it was fair to say that a house, irrespective of who owns it is equally dangerous and it was hard to go back on a previous decision granting Permission. He said he was proposing the resolution on the basis of consistency. The resolution was seconded by An Comhairleoir Ni Fhatharta.

The County Engineer read the following report which had been circulalted to each Member prior to the Meeting:

### "LOCATION:

The site is located on the N.59 route (Galway-Oughterard-Clifden) approximately 2 miles south of Oughterard.

### PLANNING HISTORY:

Ref. No. 28305 - Outline Permission for a house refused on this site in September, 1978. Applicant: Mary Walsh.

Ref. No. 30878 - Outline Permission refused as per 28305 - May 1979.

Ref. No. 35506 - Outline Permission granted for a house based on essential housing need claim in March 1981 - applicant: Mary Walsh, daughter of land owner.

Ref. No. 41288 - Approval granted to Liam Creaven in respect of Ref. No. 35506.

#### PLANNING CONSIDERATIONS

The site is located on the N59 route where the maximum speed limit applies and where it is the policy of the Planning Authority to restrict development in the interests of traffic safety. This section of the route is unrealigned and narrow with no verges or hard shoulders, and with a very substandard sight distance available from the access way it proposes to share with an adjacent house.

The original Outline Permission was granted to a member of the Walsh family who are owners of the land holding. The site would then seem to have been sold to Mr. Creaven. Since the proposal does not involve the essential housing need of a farmholder's family, it does not qualify for inclusion in the category of development which is permissible along this National Route. The policy of restricting accesses on National Routes has been incorporated in all of the County Development Plans for more than 20 years in view of the established relationship between accident occurrences and the number of uncontrolled access points.

### RECOMMENDATION:

Refusal is recommended as follows:

- 1. The proposed development would contribute to a serious traffic hazard as the site is located adjacent to an unrealigned section of restricted national secondary route which is heavily trafficked and at a point where the maximum speed limit applies and the traffic generated by the development would interfere with the safety and free flow of traffic along the said route.
- 2. The proposed development would contravene the County Development Plan, Chapter 8, Table 8B which limits housing development along this road to the substantiated essential housing needs of local farmholders and their families. No such need exists in this case and the proposal, if permitted, would be contrary to the proper planning and development of the area."

The County Engineer said that at the present time, the A.A.D.T. was 2,848 vehicles with 9% heavy goods vehicles. He recommended that Permission be refused. Responding to questions as to why Mr. Creaven was granted Approval previously, the County Engineer said that Approval was granted due to the fact that an Outline Permission existed on the site. This Permission had now expired.

### PAGE 4 MONTHLY COUNCIL MEETING ON 28/9/1992

Councillor McHugh said that the applicant bought the site in good faith with no conditions attached to the Permission, and therefore, Permission should be granted. Senator O'Cuiv said that when Mr. Creaven bought the site, it had Outline Permission with no conditions about second family dwelling. He had let the Permission run out and he now wants to go back to the previous position. Senator O'Cuiv said he could not understand how the location was unsafe now and said there were good planning reasons for granting Permission. #### MINUTES:

On the proposition of Councillor Ryan, seconded by Councillor Callanan, the Minutes of Special Meeting of the Council held on the 14th August, 1992, were approved and signed by the Chairman.

On the proposition of Councillor McDonagh, seconded by Councillor Finnegan, the Minutes of Monthly Meeting of the Council held on 24th August, 1992, were approved and signed by the Chairman.

Deputy Connaughton asked if any reply had been received from the Western Health Board in relation to Minute No. 909. The Chairman read letter dated 21st September, from the Chief Executive Officer of the Western Health Board, stating that it would be inappropriate for Health Board Staff to attend the Meetings in question. Dissatisfaction was expressed with this reply and the Secretary was asked to clarify with the Health Board that the Council's request referred to one Council meeting.

Councillor Callanan referred to Minute No. 916 regarding road improvements at Kilrickle, and asked if rumble strips would be provided. The County Engineer gave details of the work being carried out and said that a proposal for rumble strips had been sent to the Department of the Environment, and the matter would be considered when the present work is completed.

Councillor O'Neachtain referred to Minute No. 908 in relation to the proposed north/south strategic road. He said that his only objection was that the proposal would not bring extra road grants to the rest of the County and could even result in less grants. Senator O'Cuiv and Councillor McClearn expressed similar views.

Councillor McHugh referred to Minute No. 922 relating to the Regional Sports Centre and said he did not remember the item being discussed at the meeting. He said he objected to such proposals unless full information was supplied to Members. The County Manager confirmed that the matter was discussed at the Meeting and gave details of the project. Councillor McHugh asked that the matter be put on the Agenda for the next Meeting, and this was agreed.

# SALE OF HOUSE TO GERARD AND TERESA O'LOUGHLIN, POLLROEBUCK, LOUGHREA:

"That Galway County Council hereby approve of the sale of a house to Mrs. Delia Curran, Lisdonagh, Headford, in accordance with the terms of notice dated 16th September, 1992, under Section 83 of the Local Government Act, 1946, and Section 90 of the Housing Act, 1966, as amended by Section 4 of the Landlord and Tenant (Ground Rents) Act, 1978, which had been circulated to each Member of the Council."

#### WESTERN APPROACH ROAD:

The County Engineer referred to the Regional Route R.336 which runs from Galway westwards to serve Barna-Spiddal-Costelloe etc. He says that this route carries extensive tourist traffic as well as local and commercial traffic. It has extensive frontage development and has a high accident pattern. He said that having examined the situation thoroughly, he had come to the conclusion that a completely new road was the only solution to the increasing problems on this particular route.

MONTHLY COUNCIL MEETING ON 28/9/1992

The County Engineer then explained, with the use of a map, the line of a new route which could be achieved. He said that the new route would be partly in the City area and would connect with the Rahoon road which would have to be widened to make the proposal feasible. The proposed route would run westwards as Stage 1 from the City to join the existing R.336 near Coismeigmore, Furbo. He said that it could be extended westwards in further stages as required to ultimately by-pass Spiddal and as far westwards as He said that the land was at present undeveloped along the proposed route of Stage 1, and therefore, it would be necessary to keep this corridor free from development to allow the road to be constructed. The length of Stage 1, including the Rahoon Road, would be 9.5 kilometres, and the estimated cost f9M. The County Engineer explained that the proposed new route could be incorporated into the present City road network via the Rahoon Road, but could ultimately be linked into a future outer ring road for the City. The County Engineer recommended that adoption of the proposed new road as shown on the

Councillor O'Neachtain said that while he welcomed the proposal, it would not solve the immediate traffic problems on the road into the City from Barna and Spiddal. He said he would also like to see the further extension of the road beyond Coismeigmore included on the map. Deputy McCormack also welcomed the proposal but said he doubted if funding would be made available as it was not a national route. Senator O'Cuiv agreed that there was a need for the proposed new road, and said that the first phase should be included in the next phase of Structural Funds. He said that he would like to get a commitment from the Department of the Environment that the road would have National Route status.

On the proposition of Deputy McCormack, seconded by An Comhairleoir O'Neachtain, the Council approved of the proposed route for a new Western Approach Road from the City boundary to Coismeigmore, Furbo, as explained on map by County Engineer.

RAISING OF LOAN OF £2.25M FOR COUNCIL OFFICES AT CLUAIN

Minute of Meeting of Cluain Mhuire Committee held on 31st August, 1992, together with County Manager's report dated 16th September, 1992, had been circulated to each Member with the Agenda.

Councillor Callanan proposed that a vote be taken on the raising of the loan. This was seconded by Councillor W. Burke. The Chairman said that he proposed to allow time for the Members to discuss the

Councillor Walsh said that he wished to recollect the events that took place in relation to Cluain Mhuire. He gave details of the visits to Cluain Mhuire by the Members and the dates on which the Council approved the purchase. He said he understood that the Staff Union had many meetings with management setting out their requirements for Cluain Mhuire and subsequently, opposition developed to moving there. He said that after the Local Elections, there was a change of heart by some Members who had approved of the purchase originally. It seemed to be accepted that if Cluain Mhuire was put back on the market, there could be a loss of £500,000, and he said the Members could not justify this loss to the people of the County.

Deputy Connaughton said that if Cluain Mhuire had to be re-sold, there could be perceived loss of between, £500,000 and £800,000 and he wanted to be assured that he would not be liable for surcharge. He asked who would make up the loss as the people of the County could not be asked to do so. Councillor J. Burke said that he had made a mistake in supporting the purchase of Cluain Mhuire. He said Cluain Mhuire would be inconvenient to the public for doing business, and he saw no difficulty in disposing of it. He proposed that the County Buildings be developed, and that Cluain Mhuire be sold.

Deputy McCormack referred to the possible loss in the event of the re-sale of Cluain Mhuire as set out in page 3 of the report. He considered the £400,000 loss to be a conservative figure. He said the Council decided that the purchase was good value at the time and he appealed to Members to make a positive decision. He questioned the high purchase costs and Architect's fees. Councillor Varley said she was influenced by the needs of the public. The County Buildings site was a good one and could accommodate a large carpark, and people could not afford the additional journeys that would be required to Cluain Mhuire. Councillor McClearn said that if the Council did not go ahead with Cluain Mhuire, it could end up leasing a premises while the County Buildings was being reconstructed and extended. Councillor Brennan

said that he was a Member of the Council when it decided to purchase Cluain Mhuire. However, there was no alternative at that time as the yard at the County Buildings was used as a machinery yard, but was now vacated. He said that Cluain Mhuire was not a modern building and would need alot of refurbishment works which could cost in excess of the estimated costs. He said that the minimum cost of purchasing and refurbishing Cluain Mhuire would be £4M, and the majority of staff were opposed to the move. Councillor O'Neill said that he would have difficulty in supporting such large expenditure on offices when there are no funds for roads, public lighting, etc.

Councillor Byrne said that many of the comments being made at the meeting would have been relevant before the purchase was made. He said the Council was 'now at a situation where it was facing a loss of up to £3/4M if it did not go ahead with Cluain Mhuire. said if the Members were concerned about the financial position of the Council, there was no option but to go ahead with Cluain Mhuire. He said he had not met any member of the public objecting to Cluain Mhuire. Councillor Callanan said that Cluain Mhuire was a good building and was bought in good faith, but was not suitable for conversion to offices. He said the County Buildings site was a good one and the Council should hold on to it. He said there was very little difference in cost in developing either property, but in the case of the County Buildings, at least half of the buildings would be new. Councillor W. Burke said that the estimated costs for refurbishing Cluain Mhuire would not bring it up to modern standards. The said the public would be inconvenienced and few staff wanted it. He said the County Buildings site was a good one, and the customer must be taken into account and the social cost. He said there was no doubt but that the Council would lose money in the resale of Cluain Mhuire. Councillor O'Sullivan said that the County Buildings was a prime site, and close to all facilities. He felt the cost difference between the two proposals would be small. He asked if the question of a surcharge would arise after a vote was

Senator O'Cuiv said that the big difference in site value between the County Buildings and Cluain Mhuire was the accessibility factor, and this must be taken into account. He said that if Cluain Mhuire was purchased at 15% below its value, it should be possible to re-sell it at 15% below its value, and that there are institutional people who would be interested in it. He believed that it would be as cheap to develop the County Buildings site and that it would be worth paying extra for accessibility. Councillor Gavin said it would be wrong if the impression got out that they were only concerned with the interests of staff. He said that the County

Buildings was on a prime site, and he doubted if the proposed loan would be adequate for Cluain Mhuire. Councillor Finnegan said that everybody was at fault as regards the delay in finalising the matter. He said that the County Buildings site has great potential and was convenient for the public. He was convinced that the development of the County Buildings was the best option. He also asked about the question of Surcharge. Councillor Ryan said that the Council could not suffer the loss that would result from the re-sale of Cluain Mhuire.

The County Manager said that he wanted to ensure that in arriving at a decision, the Members had the correct information, and this had been set out in his reports which were circulated. He said it was his duty to advise the Council, and he was doing this. In regard to the potential loss on the re-sale of Cluain Mhuire, he said that he had received advice from two sources on this. He said that the figure of £400,000, which he had included in the report, could be on the conservative side. He said that the figure of £93,000 for purchase costs in respect of Cluain Mhuire was factual. The refurbishment costs for the County Buildings were based on figures received for Cluain Mhuire, and therefore, should be a good yardstick. He said that the sum for Architect's fees was factual, and was based on fees below the normal scale of fees. As regards carrying on business in the County Buildings, while it would be undergoing refurbishment, the County Manager said that this would be difficult, and he was aware of another local authority that had to move out into another premises. The County Manager said that some of the arguments being put forward against Cluain Mhuire were not factual, and said that the Members should rely on the facts supplied by the County Manager and County Engineer, whose responsibility it was to advise them. The County Manager agreed with Councillor O'Neill's point that the Council was finding it difficult to finance its services without the burden of extra loan charges, but said that the Motor Tax Office was in extremely bad condition and needed to be replaced urgently. He said that he was trying to involve the Council in as dittle outlay as possible in providing new office accommodation. He said that Cluain Mhuire was suitable for adaptation to offices. It was on a site of 7 acres and the ground floor rooms were eminently suitable for rooms for the public to transact their business while the upstairs rooms were ideal for single offices, which staff were looking for. He said that Cluain Mhuire was well located and its purchase was an excellent commercial transaction. New offices of another local authority in a designated area undergoing reconstruction at present, and with a much smaller floor area than Cluain Mhuire would have greater annual outgoings than Galway County Council. He said that he doubted if any Institutional Body

would be interested in purchasing Cluain Mhuire in view of the State's cutback on public expenditure. He did not think it would it be desirable to develop the County Buildings site and sell one acre of it at the same time as suggested. The County Manager said that the staff decided to negotiate with management in relation to the move to Cluain Mhuire and prolonged negotiations took place. Subsequently, the staff opposed the move to Cluain Mhuire.

The County Manager said that during the debate, some Members had asked about the question of Surcharge. He said that he now had to exercise two statutory functions. He said he was formally advising the Members that if they changed their minds in relation to Cluain Mhuire, and if that was likely to result in a loss to Council funds, it was his statutory duty to advise them of the consequences. He said there was a legal obligation on him to give the Members a statutory warning if they were proposing to embark on a decision which of itself or together with a series of other decisions, could result in a loss or deficiency in the Council's funds and that the names of the Members voting for or against, or abstaining from the decision would be recorded in the Minutes of the Meeting. If a Charge was made subsequently by the Auditor, the Members causing the loss could be liable to be charged.

Senator O'Cuiv asked why the County Manager had not given the warning 15 months ago. The County Manager replied that the reason he gave the warning was because he understood that the Members were likely to make a decision at the Meeting rejecting Cluain Mhuire. Also some Members had asked about the possibility of Charge or Surcharge. The County Manager said that loan approval from the Department for the development of the County Buildings might not be forthcoming. Councillor Gavin said that as an elected representative, he would be making his decision in good faith, and he was very annoyed at the County Manager's warning. The Chairman said that the Manager was carrying out his obligations under the Management Acts. Senator O'Cuiv said that the proposal before the Council was whether or not to raise a loan and not the question of selling Cluain Mhuire. The County Manager said that he had made it clear that a decision taken at the Meeting could be the start of a series of decisions which could likely result in a loss to the Council's funds. He gave the same answer to Councillor Fahy who asked a similar question and said that he had discharged his duty as he was obliged to do. In reply to Councillor Loughnane, the County Manager said that he had made available whatever information he had. Senator Hussey said that the County Manager's statement could have serious consequences for many Members and proposed that the Meeting adjourn for a time.

When the Meeting resumed, Councillor Ryan proposed the following resolution which was seconded by Councillor McDonagh:

"That subject to the sanction of the Minister for the Environment, Galway County Council hereby approve the raising of a loan of £2.25M for the refurbishment of Cluain Mhuire for Council Offices made up of £0.5M for a new Motor Tax Office and £1.75M for the remainder of the refurbishment, the loan to be raised from such source and be repaid over such period and at such interest rate as may be approved by the Minister."

Councillor Fahy proposed that the matter be deferred to the next Meeting to allow his group get independent legal advice. This was seconded by Councillor Callanan:

Some Members referred again to the Council's liability to be charged, and the Chairman asked the Secretary to read out Section 16 of the City and County Management (Amendment) Act, 1955. The Secretary read out the said Section 16 as hereunder:

# [1965.] City and County Management [No. 12.] (Amendment) Act, 1866.

16.—(1). Where a proposal is made at a meeting of a local Obligation of proposition of propositi

(a) which constitutes a reserved function or is mentioned in a pay resolution under section 4 of this Act, and

(b) in consequence of which an illegal payment is to be made out of the funds of the local authority, or a deficiency or loss is likely to result in or to such funds,

the manager (or, in his absence, such other effect as may be designated by the manager; shall object and state the grounds of his sobjection, and, if a decision is taken on the proposal, the names of the members present and voting for and against the decision and abstaining from voting on the decision shall be recorded in the smithtes of the meeting.

- (2) Subsection (2) of section 61 of the Local Government Act, 1925 (No. 5 of 1925), shall cease to have effect in relation to a local authority.
- (3) Where, in accordance with subsection (1) of this acction, the names of the persons voting for a decision to do or effect any act, matter or thing are recorded in the minutes of the meeting of a local authority, those persons shall be surcharged on any surcharge or charged on any charge that may subsequently be made as a result of the decision as if they had made or authorised the making of the payment or caused the loss or deficiency, and no other person shall be surcharged or charged.

Councillor W. Burke proposed that the Council's Solicitor be invited to the Meeting. The Chairman said that he now had three proposals, and following some discussion, it was agreed to adjourn the Meeting to 8.00 p.m. and to contact the Council's Law Agent in the meantime.

The Meeting resumed at 8.00 p.m. with Mr. O'Donoghue, Law Agent, present. The Chairman referred to the fact that some Members had said that they were not aware of their liability in relation to charge and surcharge and reminded them that each of them had received a booklet from the Minister giving details of their powers and duties. He said that on page 48, the Manager's obligation to advise Members was clearly spelt out, and he read out the Section from the Booklet. The Chairman asked the Law Agent to explain the position regarding the Councillors liability.

Mr. O'Donoghue said that he regarded Section 16 as a logical corollary to Reserved Functions, i.e., that Members are accountable for their actions, and that there was an inbuilt warning system which the Manager had fulfilled. He said that the County Manager was the professional adviser to the Council, and where a proposal is made at a meeting, which in the opinion of the Manager, is likely to result in a loss of funds, he is obliged to object and advise the Members that the names of the Members voting for and against, will be recorded etc. He said that any loss was a matter for the Local Government Auditor. Mr. O'Donoghue replied to a number of questions from Members as follows:

He said that the question of charge would still apply even though a decision might be made with all sincerity and without any intent. He said that loss would include conequential loss in his opinion and that it was the Members voting on the proposal that would be responsible not previous Members. He said that the amount of the loss would be a matter for the Auditor. He said that he was the statutory person appointed to give legal advice to the Council and nobodyelse. He said the County Manager could not give the warning to the Members in order to get his own way, and could only use it in appropriate occasions, this being one of them. In his opinion, the County Manager had given the warning at the correct time. Should the cost of refurbishing Cluain Mhuire cost more than estimated, he said that the with intent.

On the question of voting in the positive or negative, Mr. O'Donoghue said that in his opinion, Members could be liable to charge once the result of their vote resulted in a loss to the Council funds. He said that the Council had the power to stop the purchase of

Cluain Mhuire when it was put before them. The Council had reached a stage in the development where, if the loan was not passed, the scheme would come to a halt, and in the Manager's opinion, a loss could result. As to whether or not the Members would be charged, Mr. O'Donoghue said that if a charge arose from an Audit, the Members causing the loss would be liable to be charged. He said he did not know if Members had ever been charged or surcharged as this is not a matter which comes before the Courts. If the value of the County Buildings appreciated after refurbishment, this would not help the issue, as in his opinion, one building could not be balanced against the other. He said that there was nothing in the Contract to purchase Cluain Mhuire about the use of the building. What was binding the Members at this stage was what had gone before, i.e., that the Council had purchased Cluain Mhuire for a well known purpose.

Councillor Ryan then proposed that his motion be put to the Meeting, and this was seconded by Councillor McClearn. The Chairman put Councillor Ryan's motion for the raising of the loan to the Meeting, and the result was as follows:

Adoption of the minutes of meeting of 9th July, 1992 was proposed by Clr. M. Fahy and seconded by Clr. T. Walsh.

Arising from the minutes, the members were informed that sponsorship for the Arts Awards had now been secured for all 5 Electoral Areas.

A letter was read on behalf of the Arts Groups in the city pledging recognition of the County Council's support for arts events in the city, and pointing out that this had already appeared on letterheads and brochures.

#### ARTS AWARDS;

The Chairman informed the Committee that Clr. T. Byrne had approached Clarinbridge Crystal for sponsorship of the main award. They agreed to this on the basis that we buy the other prizes there. This was welcomed by the Committee and arrangements would be put in train to contact the shop. A discussion took place on the allocation of prizes and it was agreed as follows:-

£200 prize for each E.A. (£1,000) Balance of £500 to be spent on Reception and advertising.

The Arts Organiser informed the meeting that he had been in contact with a hotel in the county regarding a reception but the Committee considered the probable cost was too high. Clr. P. McHugh thought that a central location should be chosen. Regarding the type of reception Clr. T. Walsh did not think that sponsorship money should be spent on an expensive reception. Clr. J. Burke suggested that the RTC might be prepared to cater for the event. It was agreed that RTC be contacted with a view to availability and cost.

The Councillors expressed various views on the question of invitations but it was decided to defer consideration of this until the next meeting.

It was unanimously agreed, that the Minister of State for Arts and Culture, Deputy Tom Kitt, be invited.

The Chairman said that advertising of the event should commence as soon as possible and the Co. Secretary and J. Harrold undertook to draft an advertisement and contact journalists and Galway Bay FM.
