The County Engineer in presenting his report stated that this stretch of road was the most accident rated in the county and a report prepared by An Foras Forbartha had highlighted this aspect. There were a great number of right-turning movements on this road and the proposed development would create additional traffic hazards.

LOCATION:

The site is located on the Galway/Spiddal Road, two miles east of Spiddal.

PLANNING HISTORY:

PR. No. 16698 - Outline Permission refused for two houses on the 30/5/74 by the Planning Authority and the Minister. Applicant: John Feeney.

PR. No. 24003 - Outline Permission refused for two houses by the Planning Authority on the 25/4/77. Applicant: John Feeney.

PR. No. 69582 - Permission refused for one house by the Planning Authority in December 1993. Applicant: Eibhlin Ni Fheinne.

PLANNING CONSIDERATIONS:

The site is located on the seaside of the Galway Spiddal Road which is zoned as "Outstanding Scenic Amenity" in the County Development Plan. The Plan also indicates views of Special Amenity Value along this section of road. Chapter 9 of the Development Plan states that it is the policy of the Planning Authority to prohibit development in this area other than development in the "essential housing need" category, and to strictly control any development which would seriously obstruct or detract from the views and prospects.

The Plan also states that special consideration will be given to development which is in the essential housing need category but which would otherwise be unacceptable for visual amenity reasons, but that alternative locations on family lands will be examined.

Chapter 8 and Table 8B of the Development Plan restricts development along this Regional Route to the essential housing need categories where an alternative vehicular access is not available onto another roadway from family lands.

In this case, it is considered that a house located on this site would seriously injure the visual amenity of the area and would detract from the panoramic view of Galway Bay and the Aran Islands which is available from the public road and which the Plan seeks to preserve.

There are extensive family lands north of the Galway/Spiddal road with frontage onto minor roads where sites would be acceptable to the Planning Authority. There have been at least five grants of planning permission on family lands north of the Regional Route.

RECOMMENDATION:

Refusal is recommended as follows: -

- 1. "The proposed development would endanger public safety by reason of a traffic hazard because the site is located on a heavily trafficked regional route where the maximum speed limit applies and the traffic generated by the development would interfere with the safety and free flow of traffic along the route".
- 2. "The proposed development is located in an area of Outstanding Scenic Amenity (seaside of R336) where views of Special Amenity Value are listed in the County Development Plan. It is the policy of the Planning Authority to prohibit development in areas of Outstanding Scenic Amenity other than development in the essential housing need category. It is also the policy of the Planning Authority to strictly control development in views of Special Amenity Value which would obstruct or detract from these views and prospects".

Cllr. O'Neachtain stated that there is a case here for this application. He added that he would set out the points as were stated in the County Development Plan. He wished to make comments on the proposal and address the County Engineer's reasons for refusal of the planning permission. He agrees with the County Engineer that the road is abysmal. The R336 is a disgrace as a Regional Road, he continued. However, at the very position it is proposed to construct this house, there is a very clear line of view for traffic coming from the site. The junction of this site onto the main road has a very clear view for a considerable distance, much greater than any other sites along this road. He believes that the site distance envisaged is in excess; it is over 300 metres for traffic coming from the Spiddal side. He further added that site distance from the Galway side is quite adequate coming within the specified site distance of 230 metres. He believes that the site distance envisaged here is much better than other sites on the road. He actually measured the site distance and found it to be more than adequate as specified in R.T.181. He stated that the applicant proposes to build a car park area in front of the site where already a footpath exists. He further added that this measurement of site distance was quite adequate for this particular site and was satisfied that the danger involved was not great at

this location. Cllr. O'Neachtain referring to Reason No. 2 for the refusal of planning permission stated that the location of the site is not in an area of Outstanding Scenic Amenity but it is in an area of High Amenity. He further continued that because of the slanting nature of the land, this house would not be seen from the public road. The Councillor then outlined the various measurements regarding its location in respect of the site and the road concluding that a person at road level would be level with the ridge height of the house and would in fact overlook the house as one looked towards Galway Bay. He felt that the two points for refusal should be reconsidered and stated that the level of the house would not interfere with the scenic amenities of the area.

He further added that there were three other houses built beside this site but understands that this fact cannot be taken into consideration. However, if three houses got planning permission, then this house should also as it is in the same location. The Councillor then drew attention to the land along the minor road. It was outlined in the planning application that these lands to the north are not admissible sites and cannot be built upon as there is no roadway or facilities for water or adequate electricity. He felt that these points should be taken into consideration but were often neglected in an essential housing need case. He further added that other family lands often cannot be taken into account. The applicants father in this instance had apportioned the land to other members of the family and this was the only site now available. The other sites which are not suitable should be examined by a ground inspection. Even if sites were available, anyone coming onto the main road would be doing so at a blind corner and would therefore be a more dangerous traffic hazard. The Councillor stated that he realised that this road was more dangerous than any other road in the County. He asked that the Council take serious consideration of this application and stated that he could not understand how this application would be refused.

Cllr. Joe Burke requested to know if this application came under a second family dwelling and wished to know would the Law Agent for the County Council be present at future meetings. He referred to Cllr. O'Neachtain's presentation as excellent but wished to know as the Law Agent represented Management, could he not also advise the Members in Section 4 cases. He felt that if this was not a valid Section 4, then Cllr. O'Neachtain should be told so and allowed to rectify the situation.

Cllr. O'Neachtain asked if the Law Agent considered the Section 4 to be valid and if he considered that the County Development Plan was adhered to.

Deputy O'Cuiv stated that one should look at Reason No. 2 for refusal. This is an area of High Scenic Amenity and not an area of Outstanding Scenic Amenity. He accepts that it is a road with special views but understands that the roof level would not obstruct the view. He stated that the proposal to come onto this main road would be much safer than a proposal coming off a county road. With respect to alternative lands, he further added that alot of family lands do not come into question because they are unsuitable or are not available. This present site has difficulties he is aware of from the County Council but felt that the visual view aspect could be overcome in this particular case.

The County Engineer addressed the points raised by the Council Members. With respect to site distance, he stated that his report did not refer to this point. The report stated that the opening of an access would cause a traffic hazard.

With respect to the designation of the area, this site is in an area where there are outstanding scenic views shown clearly on the map and that he accepted that the area south of the site as being designated an area of Outstanding Scenic Amenity. He could not accept the point of overlooking of the house. The proposed house would be on the sea side and would be visible from the road. He stated that there are sites on the realigned portion of the road which the County Council would consider as alternative sites. There was a recognised access at this location. He further added that there was no dispute as to a second family dwelling claim and does not agree that the other lands owned by the father are remote. The fact that the father distributes the land does not indicate that planning permission will be granted or that they are entitled to get planning permission. He stated that there must be a limit put on openings onto this road and that it was significant that the M50 Dual Carriageway in Dublin where there are no exits allowed onto this particular road, no accidents have occurred as a result. He further added that on this regional road, there was a high percentage of volume of heavy goods. It was felt that alternative family lands with suitable sites were available to the applicant and he again reiterated that the view from the road will be obstructed by this house adding that it was a tourist area where special views exist.

Cllr. O'Neachtain stated that the County Engineer was not familiar with the site. If driving or walking along this route, you would see nothing but the bushes. On the same site level, there are three existing houses and he requested to know if another house would affect the amenity. In his opinion, it would not. At the present moment, tourists cannot see the sea shore because it is blocked by these bushes. With respect to the other sites mentioned by

the County Engineer, the applicants brother has ownership of these sites. He stated that this was the only site that the applicant has under the allocation of lands by her father. Referring to the Rundale System of land ownership, he stated that all the land was scattered. The father had assumed on giving the site that planning permission would be obtained. He felt that the lands to the north coming onto the Regional Road would in fact be more dangerous and stated that the traffic hazard is a fact of life on this road because of the condition of the road. He also added that local people should not be victimised because of the state of the road and that in this present case there was adequate site distance available. He then requested to know if the points made were adequate to make the application valid and legal. Previously he was advised that he did not adhere to the provisions of the County Development Plan.

The County Engineer in replying to the Councillor stated that there was no intention to victimise anyone. The Council were carrying out the provisions of the County Development Plan and in the interests of the proper planning and development of the area. The County Engineer added that Liam Kavanagh and himself had visited the site and studied it in great detail. They were satisfied that the site would be an obstruction of the views in the area. He stated that he did not agree that traffic hazard was a fact of life and yet another house on this route would add to the traffic hazard of the road.

Cllr. Joe Burke then requested a reply to his earlier questions to which Mr. Tom Kavanagh, County Secretary replied that the first point of his question had already been answered by the County Engineer.

Mr. Tom O'Donoghue, Law Agent stated that it was the function of the Members to make the decision. Before the Manager signs the order he can first refer it to the Law Agent for advice. The Law Agent them must consider if the Members exceeded their legal duties. It would be improper and illegal for him to advise the Members on the present application. When dealing with a Section 4 the Council Members take on the function of the Manger and must deal with the application. He could not interject in the debate on a Section 4 and it would be illegal for him to make any comment whatsoever, to which Cllr. Joe Burke requested if the discussion that had taken place on the Section 4 invalidated the present application. He felt that they were entitled to legal advice. The Law Agent then informed the Members that he could not give legal advice on this Section 4 until the decision is made by the Members.

Cllr. O'Neachtain stated that he did not ask the Law Agent if the Section 4 was valid. He wished to know if anything had been said to invalidate the Section 4

and did not want to put the Law Agent in a predicament.

Cllr. Tiarnan Walsh stated that the Manager had the advantage of legal advice, where as Council Members had no legal advice. There is no advantage to the Council Member in this case.

Cllr. McHugh stated that the proper time to seek legal advice was not when discussing a Section 4.

Deputy O'Cuiv stated on a general question, could the Law Agent confirm that when a Section 4 is passed, if points made were relevant or irrelevant. He requested to know if it would make a difference if applicant went onto the main road through a site owned by her sister who has an existing access.

Deputy Connaughton requested to know, insofar as Section 4's are concerned generally, does it make a difference if there is a division of votes in passing a Section 4.

The Law Agent advised him that under the provision of Section 4 it must be taken before any other business of a meeting. If the debate deviates from a Section 4, this may invalidate the Section 4.

Cllr. Finnegan stated that with respect to Section 4 debates, they should be dealt with properly. Cllr. Callanan stated that once a Section 4 debate begins the vote should be taken after ten minutes. Deputy Connaughton requested replies to his previous question regarding the division of votes for a Section 4. The Motion was proposed by Councillor Michael Regan, seconded by Councillor Michael Cunningham. The County Engineer submitted the following Planning Report.

LOCATION:

The site of the proposed dwellinghouse is in the townland of Kilcornan on a county road approximately one mile from the National Primary N18 Galway to Gort road.

PLANNING HISTORY:

There have been no previous applications on this site.

PLANNING CONSIDERATIONS:

The site is located in a rural area where it is the policy of the Planning Authority as stated in the County Development Plan, Chapter 7 & Table 7A that all sites for dwellinghouses must have a minimum road frontage of 30 metres (100 ft.). The proposed development would be contrary to this requirement as the site has a frontage of less than 7 metres.

RECOMMENDATION:

Refusal is recommended in this case for the following reason: -

"The proposed development would be contrary to the current County Development Plan, Chapter 7 and Table 7A which requires a minimum of 30 metres (100 ft.) road frontage which is not available in this case as the site has a frontage of less than 7 metres".

Cllr. Regan stated that the site is a full 2 acres in size and that the house would be sited 70 metres back from the road margin. The site was surrounded by trees and the proposed house would not be seen from the road. He then questioned the status of the road and stated it was not shown on all ordnance survey

maps. With respect to the applicant, he stated that he was living in Galway and was married with a number of children. There was no house beside this site he added. The County Engineer pointed out that the road in question was a County road which leads to the County Council water works. Deputy Connaughton stated that he supported Cllr. Regan's comments. He was not on site but he was aware that the applicant could not get 100 feet road frontage. However, he would allow the rest of the land to be frozen. He stated that there was a real housing need in this case. Cllr. McClearn further added that this situation has arisen before. You are only talking about parking space and if the applicant has parking space on the site, would this overcome the frontage requirement. The County Engineer submitted that a housing need was not claimed by the applicant and that the need stated by the members would not come under the County Development Plan requirements. Cllr. Loughnane asked if it would be acceptable to submit details of the need now at the Council meeting. Mr. Kavanagh, the Acting Assistant County Manager stated that this was not the best way to consider a planning application, the applicant himself should submit all details to the Planning Office. PLANNING CONSIDERATIONS:

The site is located in a rural area where it is the policy of the Planning Authority as stated in the County Development Plan, Chapter 7 and Table 7A, that all sites for dwellinghouses must have a minimum area of 0.2 hectares (0.5 acre) and a minimum road

frontage of 30 metres (100 ft.). The proposed development would be contrary to both of these requirements as the site area is 0.142 hectares with road frontage of 26 metres.

The site is located on the entrance road to Coole Park which is an area of recreational amenity and of cultural and historical significance. There has been a substantial investment of public funds in the development of the Forest Park and in the provision of tourism facilities reflecting the areas cultural and historical importance. The proposed development, in conjunction with existing and permitted developments, would seriously devalue the investment of public funds in the area by contributing to a suburban type ribbon development which would be wholly out of character in this rural amenity area.

RECOMMENDATION:

It is proposed to refuse the application for the following reason:

"The proposed development, together with existing and permitted development on adjacent sites, would constitute an excessive concentration of housing development of suburban character in the rural environs of Gort town adjacent to Coole Park and would be contrary to the provisions of Chapter 7 of the County Development Plan which prohibits such grants of houses in the interest of visual amenity and rural character of such areas".

The County Engineer further added that a great amount of public money had been spent on widening this road. Cllr. Fahy in referring to the last meeting stated there was an essential housing need in this case. He added that the Councillors were fully confident that with the time given to the officials they would reconsider their recommendation. Mr. Brennan had to go to England to find employment. He now wanted to come back to live in this country. The Councillor felt that it would be a disgrace to turn down planning permission and that the dwellinghouse would be suitable here in this vacant site. The proposed house would blend in with the other houses. The County Engineer then stated that this Section 4 was not deferred at the request of the staff but was deferred by the members of the Council to this present meeting and that no discussion has taken place at the last meeting. Cllr. Fahy contradicted this view point. The County Engineer further added

that housing need was not an issue in this particular planning application and that the officials had nothing further to add to the report. Cllr. Fahy again stated that a housing need existed in this particular case.

The Chairman declared the resolution carried.

The Chairman allowed a discussion on Section 4's.

Deputy McCormack indicated that he had received a copy of the Decision and the Legal Advice given by the Law Agent in connection with Planning Ref. No. 70289 for Mr. P. O'Halloran. While he had received Legal Advice he had not recieved a Report of the Meeting that was submitted to the Law Agent to allow him consider his advice. It was disturbing to read the Legal Advice. The Legal Advice suggested that the traffic hazard question brought up by the County Engineer was not addressed. Deputy McCormack indicated that he had quoted eight Pages in the Development Plan to point out reasons how the Application could be considered. He asked how he could explain to Mr. O'Halloran his inability to present his representations. Deputy McCormack also queried the point that if 29 Councillors talked in favour of a Section 4 Motion that all it needed was one person to maliciously say something to knock the said Section 4. He indicated that he was prepared to seek his own legal advice on the Section 4 issue, but that while the Manager's costs would be met by the Council, he would have to pay his own legal costs. He asked to get a copy of the Minute of the Meeting

submitted to the Law Agent. Councillor Gavin indicated that in connection with the P. O'Halloran case he did not say that Mr. O'Halloran would emigrate. He was referring to Jason O'Shaughnessy another applicant for permission for a shop in this area. He acknowledged that he may have put his foot in it. He felt that the points made were relevant to the issue being considered. He indicated that he felt he did not know enough to discuss the matter of Section 4's . He asked that the Legal Officer be present to advise the Council in this regard. Councillor J. Burke indicated that he had always voted against Section 4's and asked how does the County Manager decide which Section 4's to pass on to the Law Agent. He felt that the County Manager was being selective with Section 4's being put forward for Legal Advice. Councillor Burke indicated that his Legal Advice indicated that the County Manager was not entitled to refuse Section 4's. Councillor Burke indicated that it was his intention to appeal Planning Ref. No. 70568 which was passed by Section 4 and subsequently refused by the County Manager. If the appeal to An Bord Pleanala was unsuccessful, the matter would then be taken to the High Court. He asked that Councillors be given independent legal advice. He indicated that the legal reports and reports of the County Engineer use the County Development Plan to refuse planning permission. He indicated that this was forcing the County Council to adopt a Development Plan with greater flexibility.

Councillor Ryan queried the legal advice given in the case of Mr. P. O'Halloran and the fact that no Member contradicted the County Engineer's statements. He felt that Deputy McCormack had pointed out clearly his case for this proposal. Councillor O'Neachtain in adding to the discussion indicated that he had not yet received the legal advice in connection with a planning refusal for Mr. Whyte. The right to pass Section 4's was being taken away on the basis of legal advice being received by the County Manager. He felt this impinged on the role of the Council. Any comment made could jeopardise the passing of the Section 4. He asked that the legal advice come before the Council as soon as possible. Elected representatives should have the right to submit Section 4's. He pointed out again that the Development Plan was not written in stone and that there was flexibility within the Plan. He cited the case of site frontage which had been the subject of a number of refusals in the recent past. He felt that

the Officials were not flexible. Councillor McHugh indicated that this discussion would be appropriate for Meetings set aside for the Review of the County Development Plan. This matter was not on the Agenda, but in actual fact had been discussed at the last three Council Meetings. He indicated that Councillors were not stopped from putting in Section 4's.

The County Manager said he acknowledged the right of Councillors to lodge Section 4's. He indicated that the Law was quite specific. There were only two reasons that permission could be granted and that was in accordance with the proper and development of the area and with regard to the provisions of the Development Plan. The law was quite clear also that the Councillors cannot bring matters outside planning into consideration. With regard to procedure he indicated that Section 4's were always referred to the Law Agent for advice. The actual procedure with regard to submitting and discussing Section 4 was in the hands of the Council. He had no problem with regard to implementing valid Section 4's.

Deputy McCormack raised again the question concerning his request for a copy of the Minute that went to the Legal Adviser in the case of O'Halloran. He indicated that when the Local Government Act, 1991 was going through the Dail it was considered that where a majority of Members spoke in favour of the Motion it was sufficient to pass a valid Section 4.

Deputy McCormack referred to the Task Force which was headed by the former County Manager and which he was involved himself to set up businesses in Galway on foot of the collapse of Digital People were advised by the Task Force to set up in business where they could not get other employment. This seemed nonsensical on the basis of the refusal of planning permission in this particular instance.

The County Manager indicated that he would supply the account of the discussion concerning the O'Halloran Section 4 to Deputy McCormack. The County Manager also indicated that 87% of Applications submitted to the Council were granted. He felt that the Section 4's while contentious were hiding this fact. The County Manager reiterated again that he implements all Section 4's that are legally passed by the Council

Councillor Burke enquired whether the legal advice

given was always given to refuse applications. The County Manager indicated that this was not right. Councillor O'Neachtain, seconded by Councillor Gavin proposed that the Law Agent attend meetings of the Council. The letter indicated that the Minister for the Environment was willing to fund the development of a Sewerage Treatment and Collection System for the Village on the basis the Maximum Grant from the Department will not exceed £500,000. Mr. T. Kavanagh, Acting Assistant County Manager indicated that the Council's Technical Advisers had been asked to look at the proposal for Williamstown with a view to coming up with a scheme to comply with the requirements of the Department of the Environment and the funds being made available. He felt that a report on this matter would be available in approximately two weeks time for the consideration of the Council.

Councillor Toddie Byrne raised the question of the travellers who were camped at Saleen Point, Rinville Park. The Acting County Secretary informed the Council of the current position with regard to prosecutions for trespass that Galway County Council

The County Engineer outlined the Insurance requirements in connection with works on public roads with regard to signposting. Councillor O'Neachtain referring to the correspondence that had been circulated from the Department of the Environment that there were no funds available for Land Use Transportation Study, asked whether the new road as envisaged would come under the National Roads Authority. Deputy McCormack supported the case for immediate funds to be made available for the Galway Western Approach Road. He felt that there was no need for the Transportation Study. He raised this matter by means of Dail Questions and was told that funds would have to come out of the Council's own allocation. He felt what was needed was the designation of the road as a National Primary Route. Despite the money being spent there was little improvement on the road in question. He indicated that Galway Corporation were retaining corridors on foot of planning permissions. He proposed that the Western Approach Road be

declared a National Primary Road for this purpose. The County Engineer in reply indicated that the Land Use Transportation Study would cost approximately £250,000. It was the key to the greater Galway traffic problems over the next 20 years. In 1978 the Eastern Approach Road and the By Pass of Oranmore had alleviated part of the problem with traffic coming from the East. The European Union require plans/reports if questions of funding are to be considered. He pointed out also that the Tuam Road was heavily overloaded from a traffic point of view. He indicated that the R 336 cannot be upgraded. The only solution was a new road. He pointed out in response to Deputy McCormack that the work that the Corporation were dealing with related only to local traffic. The overall project at £9 M .was not a particularly large project in the context of roadworks currently being undertaken in the Country. It needs a specific allocation. The replacement of the road is not within the ambit of the National Roads Authority. He indicated that after the completion of the Land Use Transportation Study consideration could be given to the reclassification of roads. Deputy McCormack indicated that if the Council have to wait for the completion of the Land Use Transportation Study it would be two years before an application could be made for the road. He felt that there was an urgent case to be made now for National Primary Road Status for the new road. This was seconded by Councillor O'Neachtain and agreed by the Members.

PEDESTRIAN CROSSING/SCHOOL LIGHTS

He suggested that the possible provision of one pedestrian crossing and two sets of flashing lights in each financial year be considered at Estimates time. The County Engineer indicated that he would make recommendations on the locations based on the necessary warrant. If there were any groups that were willing to provide funds the County Council would erect flashing lights. The main demand was on non-national roads. He also indicated that Notice of Motion money could not be spent on National Routes.

HEDGE CUTTING

Councillor K. Quinn felt that it would be appropriate if the FAS Schemes operated by Galway County Council carry out Hedge Cutting which was required urgently throughout the Country. Councillor McHugh indicated that this matter was now urgent. The County Engineer outlined the responsibility of owner/occupiers under the Road Traffic Acts concerning hedges and drainage on roads. Councillor McClearn indicated that the

costs of hedge cutting would be less if private people were employed and allowed to carry out the work outside normal working hours. Councillor McHugh referring to the Tuam Area said that if there was money available now or if it was envisaged that money would be available later in the year that the hedges should be cut now. The County Engineer indicated that the men were only back from three weeks holidays and that the most urgent requirement was that road grant money be spent.

Councillor McClearn suggested that the Council look at the spending under this heading on a mileage basis rather than per hour. Councillor Mullins asked whether the Council sought tenders for hedge cutting. The County Engineer indicated that tenders were sought. Councillor McClearn suggested also that a price for a particular job be sought. Deputy McCormack indicated that he felt it was appropriate that FAS Schemes should be used for hedge cutting purposes. Councillor O'Neachtain enquired whether the new Community Schemes would be suitable. Councillor O'Sullivan also felt that the Council should do more work concerning edging of roads where ditches and soil were encroaching on to the metal part of the roadway.

On the proposal of Councillor Mullins, seconded by Councillor Callanan it was agreed to approve the Wage Increase in accordance with Clause 3 of the PESP for General Operatives.
