RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY 2480 MANAGEMENT (AMENDMENT) ACT, 1955 - PLANNING REF. NO. 70467 - JAMES O'TOOLE

The resolution as set out on the agenda was proposed by Deputy O'Cuiv who informed the meeting that he had suggested on two previous occasions that the resolution be deferred pending a site meeting, and to allow a further chance to resolve the problem. Deputy O'Cuiv stated that housing need is not the issue in this matter, it is the location on the

family lands, and the questions to be addressed are whether there are alternative sites, and whether the proposed development would detract from the amenity of the area.

Deputy O'Cuiv stated that he had visited the site, and that he considered that the proposed development would not be obtrusive. The Deputy also informed the meeting that the applicants engineer had stated that there could be difficulty with an alternative site as the alternative land might not comply with the S.R. 6 due to soil conditions. In view of the efforts made, and the fact that the applicant would be willing to lower the floor levels, Deputy O'Cuiv considered that a Section 4 was the only option in this case.

Councillor Mannion seconded the proposal, and agreed with Deputy O'Cuiv.

Mr. Kavanagh referred to the following report which had previously been circulated to each member of the council.

LOCATION:

The site is located 1 mile west of Clifden on a County Road which links the Sky Road with the Beach

PLANNING HISTORY:

PR. No. 68054 - Outline Permission refused for dwellinghouse in November 1993. Applicant: James O'Toole.

PLANNING CONSIDERATIONS:

The site is located in an Area of Outstanding Scenic Amenity on what appears to be within the old Clifden Castle demesne. It is on one of the most elevated parts of the O'Toole family lands which stretch from the Sky Road southwards to the Beach Road.

When the decision to refuse the previous application on this site was made, the Councillors making representations were informed that the Planning Authority would consider an alternative location on family lands to the north. Although there are two existing houses on the northern part of the holding there is still adequate room for another house

without serious damage to the visual amenity of the area.

The location now proposed is very elevated over the public road level and is significantly higher than either of the existing O'Toole family houses or the two other adjoining houses south-east of the site. The site access road would also result in major excavation along the site frontage as the land immediately inside the road boundary wall is approximately 2 metres above road level and there is a steep ridge of ground between the access point and the proposed house location. This would result in serious scarring of the landscape which could not be readily restored.

RECOMMENDATION:

Refusal is recommended in this case for the following reason:

The proposed development would be seriously injurious to the visual amenities of this area of Outstanding Scenic Amenity because the proposed site is elevated, unscreened and prominent in views from surrounding lowlands. The development would not be capable of being satisfactorily assimilated into the landscape.

Mr. Kavanagh stated that it was not possible to reach a compromise for this application. In reply to Deputy O'Cuiv, Mr. Kavanagh agreed that reducing the floor level would reduce the level of the house.

RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT (AMENDMENT) ACT, 1955 - PLANNING REF. NO. 70718 - APPLICANT MR. HENRY WHYTE.

The resolution as set out on the agenda was proposed by Councillor O'Neachtain and seconded by Councillor Ni Fhatharta.

Councillor O'Neachtain stated that this applicant had applied on three occasions, that he desires to have a house built on his own land in his own area, and that the problem is due to lack of frontage. The land in front of his holding adjoining the road has been sold in blocks and the applicant cannot provide 100ft. frontage.

While Councillor O'Neachtain stated that he agreed with the County Development Plan, he considered that there are circumstances where the minimum frontage cannot be achieved. Councillor O'Neachtain stated that the applicant has 23 acres in his holding at the back, that he is willing to freeze all development of this land if allowed to proceed with the construction of the house, and the Councillor stated that if the County Development Plan does not allow for compromise, it is unworkable. Councillor O'Neachtain informed the meeting that the applicant had exhausted all other options, and that it was suggested at one stage that a material contravention be used in this case, but this procedure was not adopted by the officials. Councillor O'Neachtain also stated that the County Development Plan states that smaller site requirements will suffice in some circumstances, that the applicant has two alternative avenues into his site and that the development would enhance the area. Councillor O'Neachtain also stated that it would be irrational and impractical to suggest that all of this area would not be developed in Corboley (Morgan).

Councillor Gavin stated that he had met the applicant, that the applicant and his family were involved in horses, that there are a lot of demands for houses in the area, that it is hard to acquire 22 acres of land for the applicants activities, that he had previously discussed the matter with the County Manager who said that he would apply the material contravention procedure, and Councillor Gavin also

stated that the development plan should be considered as a guideline rather than written in stone.

Councillor Brennan questioned where the entrance to the 22 acres is located, and whether 40 ft. would be sufficient for the entrance for agricultural use. Mr. Kavanagh stated that some of the frontage had already been hard cored. Deputy McCormack stated that the proposed development would be proper planning and development of the area, that the house would be safer than using the entrance for ponies, that if the house was constructed, all farm work would be done internally, and that it was false to state that there would be a traffic hazard as the proposed development would lead to better use of the land.

Councillor J. Burke stated that the County Council has been given power by the Oireachtais to use Section 4's, that if 100ft. frontage was available there would be no need for a Section 4 in this case, and stated that for the first time, he would vote for a Section 4. Councillor Burke also stated that the will of the majority of the Council has been thwarted, that Councillors have legal responsibilities to use Section 4's correctly, and that the gate for the house would not be any more than 15ft. and therefore the amount of frontage was not important.

Councillor Ni Fhatharta supported the points which had been previously made, stated that the family have had connemara ponies and that it would be a sad day for the Council if they were to deprive this man of having his house and farm in the area. Councillor Loughnane stated that a material contravention had recently been granted for Mr. G McInerney, and in the interests of fair play, this application should be granted. Councillor Brennan referred to a previous case in Claregalway, stating that a correct decision had been made in that case and that this case was similar.

The site is located on the link road from Barna to Moycullen approximately 2.5 miles north of Barna.

PLANNING CONSIDERATIONS:

The County Development Plan requires minimum road frontage for rural sites of 100 feet. It also prohibits the unco-ordinated development of backlands particularly in the rural environs of Galway City and where there is already a surfeit of unserviced housing development. The site in question has approximately 40 feet road frontage and the applicant is unable to acquire the extra frontage necessary to comply with the County Development Plan.

RECOMMENDATION:

It is proposed to refuse this application for the following reason.

The proposed development would contravene the County Development Plan which requires minimum 100 feet public road frontage. The site frontage does not meet this requirement and the proposed development, if permitted, would be contrary to the provisions of the County Development Plan and to the proper planning and development of the area.
