LOUGHREA BYE-PASS

"that the proposal for the bye-pass approved by the Council at its meeting on the 5/5/1995 requiring three over-bridges, two roundabouts, and the deletion of the grade separated junctions be amended to exclude the provision of roundabouts at each end, to include two grade separated junctions, and that:

- 1. The grade separated junction at the west of Loughrea be re-located to the western extremity of the bye-pass.
- 2. The grade separated junction at the east of Loughrea be relocated from the Danesfort/ Caheronaun Road to the vicinity of the Greeneenagh Road.
- 3. Full access to and from Loughrea town be provided at both grade separated junctions.

This was seconded by Deputy McCormack.

Councillor McClearn proposed that no decision be made until the next Council meeting to be held in County Buildings. Councillor McClearn pointed out that the only people stopping the proposal was Galway County Council and the N.R.A. Deputy O'Cuiv indicated that the debate with regard to roundabouts versus grade separated junctions was determined by a national change of policy. It was now obvious that grade separated junctions were safer for current traffic needs. He felt that there should be room within the process for small modifications to be made to accommodate individuals concerns and grievances. The Chairman called for a vote on Deputy O'Cuiv's proposal. The County Manager indicated that the Accommodation Committee had met earlier to discuss the offer received from the Regional Technical College for the property at Cluain Mhuire. The County Manager indicated that the County Secretary's report to the meeting, contained all the facts relating to the property. Correspondence received from the National Building Agency and the Galway Regional Technical College were also included. The County Manager indicated that one of his priorities on taking up duty was to bring finality to the issue of Cluain Mhuire. In this regard he had met with the Accommodation Committee on a number of occasions and at one of these meetings he informed them that he was commissioning the National Building Agency to look at the various options available to the Council with regard to its site at Prospect Hill and also the site at Cluain Mhuire. He said that initial interest by the R.T.C. was diverted somewhat during 1994 on the basis that they had to open up a new facility in Castlebar. However, in October 1994, they renewed their interest and after considerable consultations and offer from the R.T.C. was received in correspondence dated 20th June, 1995 which had been circulated to the Council. Correspondence from the N.B.A. indicated that the offer from the R.T.C. was the best available to the Council.

Deputy McCormack referring to the report issued to the Councillors dated 1st October, 1991 pointed out that paragraph 2 could cause a problem for the Council with regard to the proposed sale of the property to the R.T.C. He questioned what impact this paragraph would have on the recommendation of the 21st June, 1995 from the N.B.A. which looked at the potential of the site for a variety of different developmental proposals and in turn recommended the acceptance of the offer from the R.T.C.

Councillor Byrne indicated that the Council had no real choice, he asked that no further expenditure be incurred until all options were looked at with regard to the proposed refurbishment of the County Buildings at Prospect Hill.

Councillor Callanan queried two items of expenditure:- £146,000 for architect fees and £117,000 which had been expended on court-house accommodation.

Councillor O'Sullivan asked was there any possibility that the Department of Justice would recoup the expenditure on court-house accommodation.

Councillor J. Burke stated that the Council were told

at the time that staff were consulted and were in agreement with the move to Cluain Mhuire. This turned out to be untrue.

Councillor McClearn felt that the Council made a rushed decision at that stage to purchase Cluain Mhuire and were doing the same now. Questions had to be asked and will be asked by the public why the County Council incurred significant losses on the transaction.

Councillor Brennan pointed out that they were losing money on a daily basis and a decision should be made now. He felt that the Council should go ahead with the proposal to sell the property to the R.T.C. He formally proposed that the Council proceed as recommended by the Accommodation Committee. This was seconded by Councillor Finnerty.

Councillor O'Neachtain said that it was essential that the Council know what plans were in place to provide new offices before any decision was made.

Councillor Finnegan indicated that the Councillors went with the recommendation of the Manager at the time. The merits of the property at Prospect Hill were brought up by staff and Unions and the Council had good reason to examine the proposed move to Cluain Mhuire.

The County Manager responding, indicated that the report as circulated set out the facts in relation to the building since it was acquired five years ago. The decision to locate to Cluain Mhuire was based on the fact that the building lent itself for institutional and office use and would provide the Council with approx. 90,000 sq. ft. of floor space compared with the available space at Prospect Hill. He pointed out that the site might be expensive to develop if any other use was involved as this would require the demolition of the existing building. Expenditure under the heading of Architects fees was on the basis that planning permission was sought for the change of use with detailed plans having to be prepared for refurbishment. There was a continuing security expense on the property. The Department of Justice had given a verbal indication that the cost of providing temporary court-house accommodation would be recouped. However, the Council had nothing in writing confirming this. The Council were pursuing the matter with the Department of Justice. If the Council agreed to dispose of Cluain Mhuire the options available with regard to the upgrading of the County Buildings would be examined. Recently the lower yard which contains the Road Design and Motor Taxation office had been included in the Urban Renewal Scheme. Any plan being drawn up would have

to cater for the Council's anticipated requirements for the next 25 years. Any proposal should ensure that the Council maximise the potential of the site. The N.B.A. would be asked to complete their report and also to address the various options available for the development of the site. This might include for the phasing of development over a number of years. The capacity of the Council to fund the proposed development of the Prospect Hill project would have to be addressed.

Councillor Loughnane asked if the proposal went ahead would all activities of the Council be located centrally under one roof. He asked that contact be made with the Office of Public Works to ascertain whether it was possible to rent office accommodation to such agencies. He was surprised that the site was split in two by the Urban Renewal Scheme.

Deputy Connaughton indicated that a decision would have to be made at this meeting. The condition of the buildings at Prospect Hill was scandalous. Deputy McCormack asked that the County Manager address the question raised by him.

The County Manager indicated that the Council had acquired the fee simple of the building and were in a position to sell the building to the R.T.C. which was in effect making same available for another public use if the Council so decided. The Acting Assistant County Manager indicated that at the time of purchase the Redemptorists were told that the Council were buying the property for County Council offices. That was the intended use at the time but it was not a condition of purchase.

Councillor Mullins appreciated the difficulties that staff had if they moved to Cluain Mhuire but the Council had made an effort to provide adequate facilities and question marks were now raised over the Council's ability to proceed to develop the Councy Buildings given the number of priorities and decisions that were facing the Council in relation to waste disposal, roads, maintenance of sanitary services etc.

Councillor McClearn expressed his concern about making a decision today. He felt that the matter should be adjourned.

Councillor Walsh supported the recommendation of the Accommodation Committee. Deputy McCormack indicated that the cost of refurbishment would put a strain on the Council's finances. Consideration should be given to the disposal of the site that was designated under the latest Urban Renewal Scheme.

The Cluain Mhuire property would be an asset to the R.T.C. in the long-term as it would allow their third level major educational base in the city to expand further.

Deputy Connaughton asked whether there was any possibility of recouping the short-fall on the transaction from any Government Department. He questioned whether the County Manager was happy that it was possible to fund the refurbishment and not impinge on the provision of services by the Council.

Councillor Callanan indicated that Cluain Mhuire was a bad buy and the Council should now dispose of same and cut their losses. Councillor Varley indicated that she opposed the move to Cluain Mhuire from the start.

The County Manager indicated that he appreciated the difficulty and the importance of the decision to be made by the Members. If the Members agreed to the disposal of Cluain Mhuire to the R.T.C., he would be in a position to have a report on the strategy for the site at Prospect Hill available within the next 3/6 months. This would involve looking at all the options available and the possible phasing of the refurbishment works.

The Chairman called for a vote on the proposal "that the Council dispose of the Cluain Mhuire property to Galway Regional Technical College for the sum specified in the report of £1.55m".

the meeting that a Minute of the Special Meeting of the 5th May, 1995 had been sent to the National Roads Authority. The A/County Secretary read the letter from the National Roads Authority dated the 19th June, 1995 which had been circulated with the agenda for the meeting.

Councillor Fahy and Councillor Loughnane asked that in fairness this matter should not be discussed at their meeting in Lettermore. The correspondence should go to the Loughrea Councillors for their recommendation and then revert to a full meeting of the County Council. The Chairman pointed out that if the Council did not proceed to resolve this matter quickly there could be a possible loss of the project to County Galway. This was implied in the correspondence from the N.R.A.

Councillor Brennan indicated that he liked the plan presented by the Council Engineers. Councillor Fahy asked that the matter go before the Loughrea Councillors and that a recommendation to the full Council from the Loughrea Councillors would be the proper way to proceed in this matter. Councillor Byrne indicated that he questioned the number of people opposed to the grade separated junctions. He felt that the Council had gone as far as they could in discussing this matter. The N.R.A. was the supreme body and he felt that the Council should now proceed to make a decision on the matter.

Councillor Callanan indicated that deputies were to meet with the N.R.A. to try to have roundabouts included and he enquired whether any meeting had taken place.

The Acting Assistant County Manager, Mr. T. Kavanagh indicated that the Council had requested the N.R.A. to attend a meeting of the Council to discuss the matter of specific refusals for extension of speed limits. The N.R.A. had indicated that they would come to a meeting but they would not discuss specific items. It was agreed to again request the N.R.A. to attend a Council meeting.

Councillor McClearn stated that this matter had been discussed at length and the N.R.A. were not being honest with the information being given. He agreed with Councillor Fahy that the matter should not be discussed in Lettermore. He said that Deputy Treacy and Senator Fahy indicated that if proposals were sent up with roundabouts they would get the agreement of the N.R.A. for same. He felt that a decision should be made in the County Buildings and not in Lettermore.

Councillor Regan indicated that for 25 years Loughrea had sought a bye-pass. It was now time to make a decision. If a decision is not made there could be a possible loss of £7m investment in County Galway. Councillor Loughnane indicated that there was a reference in the letter concerning economic return figures and he asked for further information on this point. He also pointed out the N.R.A. had made no mention of over-bridges. Councillor J. Burke felt that the letter from the N.R.A. was clear. The Council had listened to all legitimate grievances and the needs of the people of Loughrea. One had only to look at the fact that lights were now being provided at roundabouts. Modern thinking indicated that grade separated junctions were the way to proceed. He recommended that the Council pass the Loughrea Bye-pass Plan today as proposed by the Officials.

The Chairman indicated that the N 6 was one of the routes designated as part of the Trans European Network. He felt that some objectors concerns were mis-guided and the Council would not make the N.R.A. change its mind.

Councillor Hussey said he understood the anxiety of the people of Loughrea but the Council had to look at the matter in the context of County Galway . He asked that the meeting adjourn for five minutes.

The County Manager indicated that this was a very important project. The letter from the N.R.A. clearly indicated that:-

- 1. Roundabouts were not appropriate.
- Significant improvements had taken place on the N 6 and Loughrea was one of the remaining bottle-necks on this route.

The County Manager indicated that the Council had been very fair to Loughrea and £300,000 had been provided in improving car-parking infrastructure in the town.

He pointed out that grade separated junctions are safer and more beneficial and that it was important that the Council make a decision today and he recommended that they proceed with the Loughrea Bye-pass proposal without roundabouts.

Councillor Gavin said he was concerned about the delay on the project. He indicated that two representatives of the N.R.A. had recently attended a meeting of Kerry County Council and urged the Council to make a decision to meet with the N.R.A. as soon as possible. Councillor Hussey indicated that it should be possible to make minor changes as the project

The Members agreed that the Development Plan would be considered at a Special meeting prior to the June Monthly Meeting to be held on the 26th June, 1995. It was also agreed to take items nos. 3 and 4 on the agenda at this point.

Councillor O'Neachtain asked that he be given rermission to bring up the correspondence concerning the allocation of funding on the N 59, which had been agreed with the National Roads Authority. He asked that same be listed on the Agenda for the June monthly meeting. The Members suggested that this matter be discussed at the Area Meetings of the Connemara and Galway Rural Councillors. REVIEW OF COUNTY DEVELOPMENT PLAN

3092

The Deputy County Manager outlined the timetable for the consideration of the Draft County Development Plan. Deputy McCormack stated that a number of further meetings would be required in order to discuss the review.

Cllr. Loughnane stated that the members submissions had not been fully discussed or considered and there was no point in having a draft until these submissions were considered.

Mr. Callagy informed the meeting that all of the members submissions were discussed at a meeting prior to the Christmas break. He added that everything had

been explained and referred to in the plan. The draft plan would be prepared indicating the changes made.

Cllr. Loughnane stated that the planners had got a chance to answer the members questions but the members themselves did not get any opportunity to reply back.

Deputy Connaughton stated that the members could spend another two years discussing the review of the plan, there will be items in the plan which members will not agree with and he understood ClIr. Loughnane's point of view but he hoped that a draft could be adopted and changes made at a later date in the draft plan.

Mr. Callagy informed the meeting that chapter 9 (Amenity Areas) would now be discussed. He proposed to outline the differences between the current plan and the proposed draft. The previous plan had two amenity areas while the proposed draft would have three such areas. The family housing need category had been widened and the beneficial housing need provision had been omitted. Referring to the Slieve Aughty mountains which were now being zoned as high scenic amenity, there were no changes as far as housing was concerned. The main reason for this zoning was to ensure the Department of Forestry refer forestry applications to the County Council for consideration. Presently, such applications were being considered by the Department without any input by the County Council. With respect to the agri tourism provision, he stated that discussions had taken place with the IFA and this provision was inserted as a result. On signage in the Gaeltacht areas the Irish language will predominate and the provision of the plan will provide for this. Mr. Callagy then read through the document which had been circulated to the members on chapter 9 and referred to a map display which was presented to the Council

Cllr. Mannion stated that pockets within the areas designated as Outstanding Scenic Amenity could take development which would not affect the amenity of these areas.

Cllr. Cunningham agreed with Cllr. Mannion's statement and added that blanket covering had to be done away.

Deputy McCormack asked if the beneficial tourism provision was being omitted. He was informed that this was a proposal in the draft. Cllr. McHugh stated that it was only a proposal for its omittance.

Deputy McCormack referring to the agri tourism provision asked what assimilation meant. He requested that this word be defined and wished to

have more information on the subject. He added that there were fine buildings in Connemara which could be restored. He then referred to the Maam Cross Screebe road and the design of stone wall. This wall should be removed which was a disgrace and not traditional to the area. Referring to 9.2.3 of chapter 9 which dealt with signage, he asked if B & B signs are allowed outside houses and what was the Council's policy in this matter. He also asked how could tourism develop where there are restrictions on this matter. On 9.2.6 which deals with agri tourism, he sought clarification on the subject and referring to assimilation into landscape, he stated that many applicants would be ruled out as a result of this provision. Two of the tourism groups of houses are located in the Ballyconneely area. He added that the design of the houses at the junction into the Golf Club were terrible and a scandal.

Cllr. Gavin referring to the tourism job figures stated that these were projected figures produced by Bord Failte. He added that by the year 2,000 tourism will be the country's biggest industry. Bord Failte are telling groups to set up certain activities which may not be in conformity with the County Development Plan. In this instance he referred to a number of tourist groups in the Cullinamuck area who operate a certain type of holiday home. Referring to the essential housing need definition which states that son/daughter be included he wanted to know if niece and nephew would also come under this definition. He asked what exactly was the definition of a returned emigrant. He then referred to the 20 acres minimum requirement to come under this category. He informed the meeting that a lot of farms are being sold. He also wished to obtain more details about the requirement of 100 ft. road frontage.

Cllr. O'Neachtain stated that this chapter was very important and he commended the efforts of the officials in putting this document together. He stated that the members must get this document right as it will be in force for the next 5 years. He added that no one wants the destruction of the amenity areas of the County and that there must be an effort to assimilate development and the needs of the local population. He added that along the sea board there is high density of population. He stated that pockets of development in this area need to be looked at. The density of development was so high that the high amenity zoning did not hold as a result. There should be an allowance for in fill in such areas. Areas of high scenic amenity have to be protected but a lot of matters are left to interpretation. He then referred to the signage details and welcomed that such signage would be in Irish in the Gaeltacht areas. He would go further and have signs in Irish only. The Councillor then spoke on the minimum requirement of 100 ft. road frontage. He stated that one must agree that there are exceptional cases to

this requirement and referred to a particular case where an applicant had 23 acres and only 40 ft. road frontage. On the definition of essential housing need he stated that he would be doubtful about the term son or daughter and added that relative could be included. He did not agree with the definition of farm-holder and stated that this should be changed to a local landholder/owner. He would like to see these points addressed. He stated that this chapter was very important to Connemara. He agreed with having planning restrictions but stated that there must be an allowance for local people to build in their own area and suggested that a special meeting of Connemara Councillors be held on the difficulties of assimilation. He stated that development when completed satisfactorily can be assimilated into the landscape. He agreed with Cllr. McCormack about the development taking place in Ballyconneely.

Cllr. T. Byrne welcomed the improvements in the chapter and referred to the areas of outstanding scenic amenity and welcomed Ballinderreen/Kilcolgan was no longer zoned. He added that he was glad that certain other areas were zoned. Referring to the Burren area he stated that this locality was being handed over to people who were now in that location such as hippies. With this zoning it is making it difficult for genuine people to come in and build. He was surprised that no one from the Planning Authority or the Health Board had done anything about the problem. He added that by shading this area the Council were handing it over to these type of people. He stated that in areas of high scenic amenity there is no reference to rural essential housing need as there is in the outstanding scenic amenity category and added that he felt that this should be put in. On the Slieve Aughty area he was told that the only reason it was shaded was to ensure that Coilte would refer forestry applications to the Planning Authority. He agreed with Cllr. O'Neachtain on the definition for the essential housing need and that this should be extended to a brother or sister together with a farm-holder being changed to a landholder. He added that he wanted rural essential housing need claim included with the areas of high scenic amenity. He then referred to 9.2.4 on development centres and the aim of the plan to put all development into towns and villages. He added that many of the towns and villages have no room to develop and it is not possible to get speed limits extended. He could not support this plan unless the town restrictions were taken away. He expressed his support regarding the development of old farmhouses.

Deputy O'Culv stated that he accepted that a lot of work had gone into this chapter and added that he would go along with certain items in the chapter. He added that the same criteria should apply for both inside and outside urban areas. He said that people

from Connemara have a right to have a house in Connemara. Referring to the tourists who visit the area he stated that approximately 85% never leave the main routes and to protect the visual amenity, people should be discouraged from building along such routes. He said that there was no threat to building on mountains and hill areas as landholdings here are in commonage. He stated that the following should be incorporated into the plan "people should build where there are traditional settlements". Referring to the proposal on the development centres he stated that this was self defeating. When people are encouraged to move into towns land prices go sky high and nobody builds. He disagreed with this proposal and said that it had the opposite effect from what is intended. Referring to 9.2.6 on agri tourism, he expressed his support for this proposal. He further added that he did not want to see people selling off Connemara and that an enurement clause should be attached to avoid such sales. He added that where people are encouraged to rebuild old houses which they own themselves, this would bring a tourism benefit into the locality. Referring to 9.2.7 he requested clarification on the definition of intensification of use. On road frontage he agreed with Cllr. O'Neachtain that there had to be some exceptions to the requirement of a minimum road frontage. He then referred to 9.4.1 regarding the definition of essential housing need. He stated that provision should be made for a near relative to come within this definition and not to confine it to son or daughter. He welcomed 3(b) of this paragraph but he stated that he would like to see 3(a) taken out. This latter provision would be abused where people would buy land and hold it five years and then be entitled to build a house on it. Regarding the term emigrant he stated that a lot of family members would like to have a place where they could go to on holidays which he felt they were entitled to. He requested clarification that if someone was living in Northern Ireland, were they considered an emigrant under this provision. He then spoke on 9.4.4 and stated that is was a tragedy that houses were built in a line. He added that it was time to differentiate between the terms house in a foreground and a house in the background. He encouraged people not to build on major traffic routes and in areas of scenic amenity. He added that there were visual problems with houses along main roads.

Cllr. J. Burke stated that this was the most realistic discussion they had on the plan. He welcomed the effort that had been made in compiling this chapter and referred to the provision regarding the minimum road frontage and stated that 100 ft. was an unreasonable demand. He did not agree with the road frontage concept and did not see any objection to having an avenue into a site once you had an exit that is safe. He felt that sight distance was more important that road frontage. He expressed his

objection to blanket cover which has been implemented down through the years. He stated that where development would not spoil the area then there should be no objection to proposals for building. He agreed with the concept of traditional settlements and allowing houses in such areas. He had huge difficulty with the concept of landowner. He stated that there was a difference between someone who buys a site and someone who inherits a site. Where someone inherits a site then it is family land. He would discriminate strongly between the two. He added that if someone wished to develop in a rural area, they should be allowed to do so and the Council should encourage rural development. He said it was wrong to promote otherwise. He expressed his welcome for this discussion which had been rational and reasonable.

Cllr Cunningham complemented the officials on the document circulated and added that it was the first time he had found the discussion practical. He added that this was a very important stage the members were now at. He stated that Cllr. Byrne had his 100% backing with respect to the Burren discussion. Action should be taken by the Council against the people who are living in this area who have not complied with the planning legislation. Regarding road frontage for sites he stated that this matter should be looked at, especially where sites are near towns. He requested that permissions be allowed up to the 40 mile speed limit. He said that this restriction was making the price of sites very He then spoke on the backlands development definition and stated that there should be more development allowed under this definition. On the zoning of areas in South Galway he stated there are certain areas within this category where development should be allowed. Regarding the essential housing need definition he said that this should be extended to brother, sister, niece or nephew. On old unroofed stone buildings permission should be given for their restoration especially in Connemara and South Galway.

Cllr. O Neill agreed that restrictions are necessary in planning and appreciated the difficulty in addressing this and allowing certain development within it. Referring to the current plan and the beneficial tourism provision he stated that this did not assist areas. It had the effect of allowing big operators build a scheme of houses where the local person was refused. He welcomed the provisions in 9.4.1 (a), (b) and (c). In relation to emigrants he stated that most families had divided up their land and there is usually no site left for the person who returns home. He added that if such people have a dream of returning home, then they should be allowed to return to their area. The Councillor stated that the majority of family holdings would be less than 20 acres and wanted to know how this figure was arrived

at. Permission should be granted to people who want to live in their own locality. He added that there were very few houses in his area owned by outside people. The term farm will have to be defined. He was glad to see the beneficial tourism definition out of the Draft County Plan.

Mr. B. Callagy then replied to the members. He firstly replied to Deputy McCormack's point and referred to the beneficial tourism provision in the present County Development Plan. He informed the Deputy that this provision was inserted by the members against the advice of the planners when the present plan was being drawn up. As regards the erection of stone walls he was not familiar with the particular case mentioned but he agreed that stone walls should be built carefully and sensitively in scenic areas. In relation to signage he stated that certain signs are exempted under the Local Government Planning and Development Regulations. As regards the assimilation of development into the landscape he stated that this was left to the planners judgement. Referring to the houses being built in Ballyconneely, he stated that a hotel had been permitted on the site and the houses were granted as a replacement. He would hold his judgement on their design until the development had been completed. With regard to the area zoned in Ballyconneely, he informed the members that the most scenic area had been included in the zoning. Mr. Callagy then referred to Cllr. Gavin's points and advised him in relation to Category 1 zoning. He stated that if the development does not injure the amenity of the area, a planning application will then be considered on its merits and where it has to be refused, a second family dwelling claim will be considered. The 100 ft. road frontage is based on septic tank requirements. If less requirements are allowed, then this will lead to difficulties in locating the percolation area.

Cllr. O'Neachtain stated that a house could be brought to conform with the landscape and be assimilated into it. The needs of the local people must be safeguarded.

Mr. Callagy stated that there had been an excessive amount of development because of the concessions allowed in the plan. He added that people ignore compliance with conditions. The question of assimilation is not being addressed. He informed the members that he would look at the definition of essential housing need and refer back to them. Regarding Cllr. Byrne's submission he stated that what he referred to was unauthorised development and would be dealt with by planning control. He informed the Councillor that a second family dwelling is allowed in Category 2 areas.

Cllr. J. Burke stated that his main priority was local people and that he represented them. He felt

that they should be allowed build houses where they want to.

Cllr. Ryan stated that this was one of the best meetings he had attended. He suggested that the planners be brought in for the next meeting to listen to the elected members.

Mr. Callagy stated that he did not accept Deputy O'Cuiv's point about tourists staying on Regional and National Routes. He stated that the plan contains statements of policies and exceptional cases cannot be put forward which had the effect of watering down the plan. The public interest and the national interest must be considered. Regarding traditional settlements he questioned how this could be defined. On the term intensification he referred to an existing small house and said that this could not be doubled in size automatically. With regard to the 100 ft. road frontage, he would refer back to development control for their comments.

Cllr. O'Neachtain stated that if people were allowed build in rural areas, schools would stay open and requested that their views be taken into consideration.

Cllr. J. Burke stated that there must be areas within the restricted zone where development could be allowed.

Mr. B. Callagy informed the members that the Planning Authority was there to protect the landscape. Referring to Cllr. Cunningham's submissions, he stated that he would look at the definition of emigrant and also the question of the minimum 20 acres of land. He informed the members that the policy statement could not be written with a long line of exceptions and that the national interest must be protected.

Deputy O'Cuiv stated that non native development should not be allowed in Gaeltacht areas. These areas should not be open to people from the outside. He stated that a lot of people will commute great distances to avoid living in urban areas and added that development should be restricted to the local person or for a person working locally.
