The Chairman welcomed everybody and congratulated the County Manager on the Estimates as presented and his report which outlined in detail the activities of the County Council. The Chairman indicated that as in previous years the Roads

Programme for 1996 would be brought to the Area Meetings of the Council at a later

The County Manager addressed the meeting and stated that revenue expenditure for 1996 was set at £41,301,853. This reflected the multiplicity of activities in which the Council was engaged and, although available resources continued to be very limited, there remained considerable growth in local services and expenditure. However, in 1996 in the context of continuing limited resources many desirable works would again have to be deferred. He referred to the factors which contributed to the increased expenditure demands including:-

higher standards for waste management

increasing maintenance and running costs arising from capital investments

limited revenue base for locally determined income.

increasing level of non-discretionary expenditure.

funding for new County Headquarters.

demands for co-financing by Galway County Council to supplement

impact of superannuation commitments.

The County Manager stated that notification of the Rate Support Grant for 1996 had not yet been received from the Department of the Environment and the Estimates were based on an assumed increase of 2.5% on the 1995 Grant. The income set out in the Estimate Tables represented the minimum required to fund the expenditure programme and provided for a commercial rate of £31.41 representing an increase of 6%. However, Galway County Council had the fourth lowest County Council rate in the Country and the lowest % rate increase over the period 1977-1995. Provision was included for a 10% increase in water charges to £127 which he pointed out only amounted to a charge of 35p per day for an unlimited supply of such a valuable commodity. He stated it was also proposed to introduce a sewerage charge of £50 together with a charge for industrial users discharging to the public sewers.

The County Manager then went through the Estimates Statement for each of the programme groups drawing attention to the most important issues. Referring to Programme Group 1, Housing & Building, he advised the members that a review of the housing maintenance function was underway and that a report would be brought before the Council in the near future. With regard to Programme Group 2, Road Transportation and Safety, he stated that the same level of Road Grants for 1995 were included in the 1996 Estimate as the Road Grants for 1996 had not yet been notified by the by the Department of the Environment. £75,000 had been included for the Community involvement in roadworks. The estimates also included an increased provision for public lighting and the Manager stated that this was an area in which community involvement will be promoted by the County Council:

Referring to Programme Group 3, Water Supply and Sewerage, the Manager stated that the Council produces an average of 5.8 million gallons of drinking water and maintains 50 public water supply schemes. Provision was made in the estimate for improvements to the water supply in the sum of £70,000. With regard to water charges, the Manager expressed thanks to those who paid their charge and stated that non-payers would be pursued. He referred also to the Tax Relief for service charges which is now available to consumers who pay their charges in full and on time. With regard to Programme Group 4, Development Incentives and Control, the Manager stated that the review of the County Development Plan was well advanced. He stated that provision had been made to increase the Economic Activity Grants from £25,000 in 1995 to £30,000 in 1996. He also advised the Members that a request had been received from the RNLI for a contribution of £20,000 over two years towards a new life-boat and that a meeting with RNLI would be arranged in the near future to discuss their request.

Dealing with Programme Group 5, Environmental Protection, the County Manager stated that the Council had already adopted a Waste Management Plan and indicated that waste management costs will rise sharply. He stated that a number of queries had been received from the private sector in the area of waste management and that it was proposed to place a public advertisement inviting interested parties to inspect the Waste Management Plan and, if they wished, submit proposals consistent with the terms of the plan. He pointed out that it was proposed to increase waste disposal, burial and fire fees. Also a draft five year Capital programme for Fire Services would be brought before the Council early in 1996.

Outlining activity under Programme Group 6, the County Manager referred to coastal erasion projects at Inishboffin and Gurteen Beach which required cofinancing by Galway County Council in the sum of £50,000. Similarly development works at Barna and Paddy Jacks Pier require a co-financing contribution from Galway County Council amounting to £10,000. With regard to the Library Service, he stated that the book fund provision had been increased and a five year plan for the library service was also being prepared. Referring to Programme Group 8, (Miscellaneous Services), the County Manager mentioned the major works carried out at Ballinasloe and Galway Courthouse. He outlined the recommendations of the Accommodation Committee in relation to the provision of new office accommodation and redevelopment of the Council headquarters site at Prospect Hill. He also informed the Members that as part of the implementation of the Strategic Plan, the reorganisation of the administration of the Council's functions on the basis of the five electoral areas was under consideration.

The Chairman thanked the County Manager for his presentation following which contributions were made by Councillors.

Deputy Connaughton complimented the County Manager on the Estimate preparation. He stated that the Department of the Environment should have some responsibility for the increased operation and maintenance costs arising from Capital investment. Also the provision of new headquarters at a time when service charges are being increased would not be well received and that the Council would need to prove it is giving value for money to the public. On the matter of the Local Improvements Scheme programme he stated that there was approximately a four years delay and he enquired what action was taking place on derelict sites. Also, what collection levels were being achieved in Rents and Water Charges. With regard

to the the state of the

to new headquarters, he asked that as much technical work as possible be carried out by the Council's own staff.

Councillor O'Neachtain expressed the view that it was very unsatisfactory that the Local Authority should have so little influence in terms of revenues while having so much responsibility for the delivery of services. He felt that the Council should also be considering overall devolvement within the County itself.

Councillor J. Burke, too, stated that the concept of local autonomy must be pursued. He welcomed the Estimate presentation and stated that the Council must look for value for money in every Department. He also felt that involvement of local communities can contribute significantly to achieving value for money.

Councillor Gavin agreed with the provision in the estimates for a sewerage charge but stated that there were a number of smaller sewerage schemes which were in need of upgrading and were already overloaded. Persons served by these schemes would feel aggrieved at the introduction of a sewerage charge. He also noted the additional burden imposed by requirements for co-financing and the Waste Management Strategy.

Councillor McHugh enquired about the effect of the new regulations limiting the water supply disconnection powers of the Local Authority on pursuing defaulters who refuse to pay their water charges. He also asked if litter wardens could be employed to prevent illegal dumping in the County.

Councillor O'Sullivan stated that the County Council had very little say financially in its own affairs and that for a very large county had a very small revenue base. He suggested that the Council become more involved with the private sector in areas such as roadworks. He enquired if facilities for the disabled were included in the development at Ballinasloe Courthouse and if there was any provision for upgrading the fire station in Ballinasloe.

Councillor Byrne stated that those who benefit from sewerage schemes should be asked to pay but that it would not be fair to impose the same charge for those on old schemes which cost little to Galway County Council to maintain.

Councillor O'Tuathail referred to the various services provided by Galway County Council but stated that, in effect, people on the Islands and the more remote parts of the county didn't have the benefit of these services, for example public lighting (etc).

Councillor Quinn referred to the four year backlog in dealing with applications under the Local Improvements Scheme. She also stated that other villages should be considered in the Urban/Village Renewal Scheme. Also the system of charging for agricultural water needed to be examined as the system of charging per trough was not fair to all agricultural users.

Councillor Ryan also referred to the system of charging per trough and that it worked in the favour of some but against others. He complimented the Engineer and his team

who maintained the water supply in the Moylough/Kilkerrin area during the exceptionally dry summer.

Councillor Mullins stated that the Council had very little leeway in how it spends its money as so much funding comes from Central Government. He felt that it will be difficult for the public to accept a 10% increase in service charges while inflation is much lower. He would like to see outside contractors engaged in Council activities such as housing maintenance.

Councillor Varley enquired if any funding was being made available for Headford Courthouse. On the matter of service charges she stated that persons who had not paid should be pursued by the County Council.

This concluded the business of the Preliminary Estimates Meeting held In Committee.

MATERIAL CONTRAVENTION OF COUNTY DEVELOPMENT 3350 RELATING TO APPLICATION FOR OUTLINE PERMISSION CHUN EASTAT TIONSCAIL LE HIONAD TAIRGAIOCHTA AGUS FOIRGNIMH TALMHAIOCHTA A FHORBAIRT IN THE TOWNLAND OF CLOONBUR APPLICANT: UDARAS NA GAELTACHTA. PLAN. REF. 70417

Mr. Liam Kavanagh, S.E.E. read out the following report:

"Description: The proposal is for Outline Permission for an industrial estate and site development works at Cloonbur.

<u>Location:</u> The site the subject of this application is located in the townland of Cloonbur adjoining the village of Cloonbur. The roadside boundary of the site fronts onto the R.345 which links Cloonbur Village with Cong Village. All other boundaries face onto agricultural/undeveloped lands.

<u>County Development Plan Policy:</u> The definition of rural areas is included in Page 65 of the County Development Plan. It states that rural areas include areas that are not:-

"...within the 40 m.p.h. (or 30 m.p.h. where 40 m.p.h. limits do not exist) speed limit zone of all (other) towns and villages."

The site of the proposal is located approximately 70m outside of the 30 m.p.h. limit on the western approach to Cloonbur Village. This location confirms the status of the site as being in a rural area and, therefore, subject to the relevant designation of Outstanding Scenic Amenity.

The development control policy for such areas is defined on Page 89 of the County Development Plan which states that the policy is:

"To prohibit development in these areas other than development in the essential housing need category."

The development being of an industrial nature does not come under this category, nor is any exceptional circumstances provided for in the policy of the County Development Plan to accommodate such uses in areas of outstanding scenic amenity. The development therefore is in conflict with the policy of the County Development Plan.

Planning History: Planning Permission granted for an Advance Factory - This site has a marginal overlap with the site of the proposed development, Planning Reference Number 45782 (1988).

Proposal: The current application is for an industrial estate and site development works on a site of 5.13ha... As this is an application for outline permission, no design details have been submitted. It has been indicated, however, that the estate will take the form of several units, possibly of varying sizes, and also confirmed to the Planning Authority that uses will be of a light industrial or service nature. Site development works will include access road, boundary walls, surface water and foul drainage, water-main, lighting, electricity and telecom provision. In addition, in light of the inadequacy of the existing public sewer to cope with the additional loading of the development, a financial contribution and a donation of a piece of land to the County Council is proposed to facilitate the upgrading of the existing sewerage treatment facility.

Assessments: The site is located within a rural area as defined by the County Development Plan. However, critical to the siting is the fact that it is immediately adjoining the village of Cloonbur and will, if built, read as an extension of the village rather than an intrusion into a rural area. The village itself does not afford much of an opportunity to accommodate a development of such a scale within its boundaries. In addition, it is better practice to have industrial type uses at a reasonable distance from residential uses so as to avoid potential conflict of interests.

The siting of the proposal facilities a connection into the public sewer and public water supply. The joint proposals with the County Council and the developer to improve the public sewer would result in an environmental gain for the area which would not come about in the immediate future without the support of the developer.

The proposal would be restricted by conditions on a grant of permission to light industrial/service type uses which are unlikely to have a substantial demand on the public services, or any significant environmental impact on the area. Clarification, however, of the details would be at approval/full permission stage.

The site of the proposal is an old woodland bounded by a masonry wall. The proposal is accompanied by a tree survey and a landscaping plan. This should ensure that the character of the area will be retained as far as possible by retention of some of the existing trees and supplementary planting. In addition, any alteration to the boundary wall will require removed materials to be re-used in the construction of new walls, thereby rendering the proposal visually acceptable from a siting viewpoint. The details of the design of the units would be dealt with at approval/full permission stage.

The entrance to the site has been deemed acceptable, subject to the carrying out of works, by the Road Design Section of the Council, thereby, indicating the acceptability of the proposal from a traffic safety viewpoint.

The location of such a development adjoining the village of Clonbur can only have positive benefits for the local economy. Not only would such a development stimulate job creation, it would also strengthen the urban base of the village. By provision of purpose built industrial units, local entrepreneurs will have the opportunity to be based locally, thereby, stemming out migration and facilitating a sustainable local economy.

Statutory Consideration: A decision to grant outline permission cannot be made unless a resolution is passed by the members, requiring that such a decision be made in accordance with Section 26(3) of the 1963 Planning Act, as substituted by Section 39(d) of the 1976 Planning Act, as amended by Section 45 of the Local Government Act 1991.

Public notice of the Council's intention to consider deciding to grant this outline permission was given on 20th September, 1995 and the notice invited members of the public to submit representations or objections, if they so wished. No objections have been lodged against the proposed development.

If a resolution is passed requiring that a decision to grant outline permission be made, such a decision will issue, otherwise a decision to refuse outline permission must issue.

FLANNERY BRIDGE, CILL SHAILE, KILKERRIN

A number of Councillors indicated that they had attended a meeting regarding Flannery Bridge in Cill Shaile, Kilkerrin. Various issues were raised. They pointed out that at the Area Meeting certain information was not made available to the Councillors at the meeting.

Professor Guiney from U.C.G. confirmed that the marine life was being destroyed and restoration of the bridge was urgently needed to restore marine plant life; failing this the Professor would write a personal complaint under the E.U. Habitat Directive to the European Commission - som Deputy O'Cuiv stated that there was marine damage and he also wished to convey that there should be full information at all times available to the Councillors in order to perform their public duties. The County Engineer informed the meeting that a decision to replace the causeway by a Bailey Bridge had been taken and same would be provided in consultation with Roinn na Mara.

Councillor Ni Fhatharta agreed with everything said by Deputy O'Cuiv. The question was raised regarding water and tides at the July Meeting of the Area Committee. The County Engineer stated that the principal objective at the time was to minimise the costs, to remove the rock and to put a temporary bridge in place. Expert advice had been received from Queens University. The County Engineer informed the meeting that a temporary bridge will be provided and the causeway removed and it was hoped to have the work completed by Christmas. The Councillors also suggested that there be no shortcuts and that there would be consultation with the local people regarding knowledge of tides and the movement of water.

Councillor O'Neachtain asked to be associated with the recommendations made. He said that he was very encouraged by what the County Engineer had to say regarding the change of structure and the erection of a bailey bridge. The Council requested that in future that the Councillors would be told that there had been a change in plan. The





LOCAL GOVERNMENT FINANCE

It was agreed to discuss the submission on Local Government Finance. The County Finance Officer outlined the following points which had been agreed by the Estimates Committee:

1. Local Authorities should operate on the basis of a sound financial structure which would include

further raising of finances on a local level in conjunction with Block Grants from the State.

- 2. All services performed by the Local Authority (including any new services) should be clearly defined to be either:
 - the full control of which would rest with the Local Authority and which would be financed by a combination of locally raised finance and State Block Grants.
 - being services which the Authority performs on behalf of the State or other body e.g. NRA, VEC's, etc. These services would include National Roads, Higher Education Grants, Courthouses, etc. and the full cost including administration and cost of money should be recouped to the Local Authority by the responsible body.
- 3. Waiver Schemes The loss of income to the Local Authority resulting from waiver of service charges to customers who cannot afford to pay is in effect a method of wealth redistribution and is a cost appropriate to the State. Waiver Schemes impact unfairly on Authorities where a high proportion of customers benefit.
- 4. The distribution of any State Block Grant (Rate Support Grant) should be fairly based on a needs and resources formula and take account of each Authorities capacity to raise local finance.
- The implementation of Multi-Annual Budgets to provide for a proper financial planning process.
- 6. Account must be taken of the annual on-going maintenance and operation costs of Capital investment in infrastructural services including EU funded Sanitary Services projects.

The Members discussed the question of local taxation and the appropriate method that may be introduced. However, there was no agreement on this point and it was agreed to defer further discussion to the monthly meeting.

REVIEW OF COUNTY DEVELOPMENT PLAN

CHAPTER 9 - SCENIC & RECREATIONAL AMENITY AREAS

The chapter was introduced by Mr. Callagy who proceeded to deal with the various sub headings. On the submission made by Deputy O'Cuiv; Mr. Callagy stated that he was not in agreement with the Deputy's request to delete the last two sentences in the first paragraph

under definitions.

Cllr. O'Neachtain stated that all of Connemara was zoned as Scenic Amenity and added that if indigenous development was facilitated, there was no difficult with the zoning.

Reference 9.0 on definitions was then agreed by the members.

Mr. Callagy then dealt with 9.1 which pertains to beneficial uses and the planning research papers.

Deputy O'Cuiv stated that it was the objective to achieve the best quality of life for the people who lived in the area. Other reasons must then be looked at on why the area should be preserved. He added that local people want to know where they stand in relation to the Development Plan.

Mr. Callagy stated that he understood the Deputy's views and agreed with the proposal that local consideration was important.

Cllr. Byrne stated he could see no problem with the paragraph except that the local interest should be considered paramount.

Deputy O'Cuiv stated that it was more important to preserve these areas for the local people and that the local interest was the national interest.

Mr. Callagy informed the members that tourism was the third highest revenue industry in the country and its importance must be stressed.

The meeting then considered 9.2 which related to development control objectives and Mr. Callagy proceeded to go through the document.

Cllr. Byrne stated that it was a reasonable objective to restrict development which would interfere with views and prospects of special amenity value.

Reference 9.2.1 on Scenic Amenity Areas was then agreed by the members together with 9.2.2 on Recreation Amenity Areas and 9.2.3. on Building Development Guide-lines.

Deputy O'Cuiv referred to the Tayout of the plan, he stated that it needed to be more user friendly. In this particular case he was referring to 9.2.4 on signage.

Mr. Callagy stated that the reason this paragraph was inserted in the chapter was to facilitate the person who reads this chapter only. He added that an index will be put in place when the plan is adopted.

Reference 9.2.5 on Development Centres was then

considered by the members.

Cllr. Joe Burke stated that they had discussed this section before and had indicated that tourism was rural based and that it was national policy to develop tourism.

Deputy O'Cuiv stated that if they were serious about developing the tourist industry, they must make provision for tourist development projects in the plan. He added that one of the major complaints was that there was a lack of facilities.

Cllr. O'Neachtain asked if the beneficial tourist provision in the present plan was left out purposely in the draft. He added that the major complaint was a lack of tourist facilities and he expressed his disagreement with the omission of the provision on beneficial tourism.

Mr. Callagy pointed out the exceptional cases provision in 9.2.5, which provide for the developments mentioned.

Deputy McCormack stated that he supported Mr. Callagy and added that the beneficial tourism provision caused a lot of trouble. He stated that some of the developments granted under the provision could not have been assimilated into the landscape and the planners were as much to blame as the Councillors who put the provision in the plan. He added that the interpretation of the provision in the plan was also incorrect and requested that such development in future should come before the members for observation.

Cllr. O'Neill stated that under the terms of the present County Development Plan, a person from outside could come in and build up to 20 houses and a local person would be refused permission for one house. He stated that the provision of holiday homes undermined the local community who provided B & B facilities in the area.

Cllr. Byrne stated he had argued strongly against this provision before but now felt that it could be looked upon on its merits.

Cllr. Loughnane stated that the term beneficial should be explained. He felt that it must be beneficial to the overall situation and that the interpretation in the old plan was loose. Applications for permission should not have been granted as the development did not assimilate into the landscape. He added that Councillors were not to blame for this provision and he stated that there should be a provision on beneficial tourism included in this plan.

Cllr. O'Neachtain stated that he believed in the merits of developing tourist centres and that it would be anti development if you leave out the beneficial tourist provision. You must have tourism related

infrastructure to facilitate tourism.

Mr. L. Kavanagh, S.E.E. referred to the background which lead to the introduction of this beneficial tourism provision in the present County Development Plan. He stated that it was difficult to interpret the Councillors wishes in certain cases and added that the primary consideration was the proper planning and development of the County.

Deputy O'Cuiv stated that in reference 9.2.5. he was of the opinion that this provision had been taken out. He added that he could not understand why specific proposals on beneficial tourism development was required. He added that such development should be considered in these areas on its merits.

Deputy McCormack stated that he welcomed Mr. Kavanagh's statement on the difficulties involved but added that he still had his own views on the provision. He stated that beneficial tourism applications should come before the Council for discussion and he asked did this provision relate to pitch and putt courses.

Cllr. O'Neachtain stated that he could name projects which benefited under the beneficial tourism provision in the plan and that the Council must look at the overall merit of the provision.

Cllr. Ni Fhatharta stated that she supported the beneficial tourism development provision and would like to see it maintained in the County Development Plan. She would like to know how many applications were applied for, the decisions by the Local Authority and the appeal decisions. She stated that she knew of areas where these types of development had been of benefit to the localities.

Cllr. McHugh stated that he supported the beneficial tourism provision in the County Development Plan and he stated that the idea was that the community groups would benefit from this provision. He opposed omitting it from the plan, He added that the development of cottages alone was not beneficial tourism in his view.

Cllr. O'Tuathail stated that before this provision was written in the plan he was against it and he would be voting against its retention. He added that beneficial tourism projects should be dealt with on their merits like all planning applications.

Cllr. O'Neill stated that beneficial development should be treated like all other developments.

Cllr. O'Neachtain stated that there was demand for this type of development and that if it was in the right format it could be left in.

Deputy O'Cuiv stated that he opposed reference 9.2.5 on development centres. He stated that appropriate

commercial tourism development should be allowed in an area. He added that everyone wants to see good development.

Cllr. Joe Burke stated that it was national policy to develop tourism development and that there was no development being allowed in rural areas.

Mr. Callagy stated that there were two issues; the development centres and beneficial tourism. On the development centres, the purpose was not to allow total development along roads and that the objective was to protect scenery in the national and local interest. He then referred to the exceptional case provision in this paragraph which would be decided after full assessment. He added that the beneficial tourism provision was initially related to tourism infrastructure but this was amended by the Councillors to read in its present format. He added that the material contravention procedure could be used for such projects.

Deputy O'Cuiv stated that you cannot have a plan where the material contravention procedure is the standard practice.

The County Manager stated that the officials will come back with another draft taking into account the discussion held at the meeting.

Deputy O'Cuiv stated that there seemed to be a big difference between the views of the Councillors and the planners.

The paragraph on state agencies 99.2.6 was then considered by the members. The sale agencies of the members are sale agencies of the members agencies

Mr. Callagy referred to the document and stated that he was not in agreement with Deputy O'Cuiv's proposal to delete this objective.

Deputy O'Cuiv stated that the policy of a certain state agency should not automatically be written into the plan for the Council to follow and in this instance he referred to the natural heritage areas.

Cllr. McHugh seconded Deputy O'Cuiv's proposal.

Mr. Callagy stated that if Government Departments have objectives, it was reasonable that the Local Authority should observe these objectives.

Cllr. Brennan stated that he had no objection to the paragraph on state agencies.

The Council then considered 9.2.7 on Agri Tourism.

Mr. Callagy stated that representations were received from the farming organisation pertaining to this provision.

Deputy McCormack stated that it was a very important provision and should be carefully written.

Deputy O'Cuiv referring to this heading stated that the requirement of road frontage and septic tank standards must be looked at in relation to the rebuilding of ruins and also a provision should be inserted so that the house cannot be sold.

The Council then agreed that Mr. Callagy would look at the definitions included under agri tourism and revert to the members at a later date.
