#### WILLIAMSTOWN SEWERAGE SCHEME

## REPORT FOR COUNCIL UNDER LOCAL GOVERNMENT PLANNING AND DEVELOPMENT REGULATIONS 1994

This report on the above development covers the nature and extent of the development and the principal features thereof.

#### Background to the Scheme

This scheme forms part of the overall strategy of Galway County Council to provide sewage treatment facilities in all its towns and villages:

The principal purpose of the scheme is to remove a constraint on the development of Williamstown and also to eliminate a public health hazard and public nuisance being created by the existing inadequate provision.

## Description of the present service provided

Williamstown is serviced by a selection of septic tanks and open sewers, a substantial proportion of the effluent discharged makes its way into an existing swallow hole and from there into the ground water system. However, before it does so it creates a substantial nuisance on the surface of the field and in a small water course leading into the swallow hole. The impact of this discharge is at total variance with our policy of improving and enhancing the environment.

#### Objectives

Our objective is to eliminate the present problem by collecting the effluent in a new collection system and then by disposing of the collected effluent in an environmentally efficient and cost effective manner.

#### Options

In pursuing these objectives we have examined 2 options

- 1. Get each individual household property to treat and dispose of its own effluent.
- 2. Provide a municipal collection and disposal system.

Having examined both options in detail we conclude that the provision of a municipal treatment system is the preferred option from an economic and environmental prospective.

### Proposed Solution

It is proposed to provide a new collection and treatment system. The disposal of the treated effluent from this proposed treatment plant creates difficulties because of the absence of an adequate watercourse into which it can be discharged. Two options were looked at to resolve this difficulty.

Option No. 1 was to pump it through a rising main to the Little Island River some 3 miles away and option No. 2 to provide a higher level of treatment on the site and to release the treated effluent into the ground water through a percolating system.

The second option is preferred from an economic point of view and consequently is included in the proposal.

Evaluate the likely implications of the proposed development with respect to the proper planning and development of the area in which the development will be situated.

The Planning Officer has indicated that the proposed development is in compliance with the proper planning and development of the area and complies with the County Development Plan.

Issues arising with regard to planning and development on foot of submissions from persons or bodies or observations made in accordance with these regulations.

No submissions have been received from interested bodies or persons.

## The Local Authorities Intentions

## REVIEW OF THE COUNTY DEVELOPMENT PLAN

3223

#### Chapter 6

The meeting commenced with a discussion on Chapter 6 which deals with land use planning. Mr. Callagy spoke on population requirements which were necessary for the maintenance of schools, shops etc. in the locality. He added that the purpose of the plan is to zone adequate land for population growth. Deputy O'Cuiv stated that this comes under Strategy 3 of Chapter 6. Was Oranmore being designed on basis of population being decided first and then decide that 5,000 people must go in there. He stated that 90% of communities are not viable if you look at the statement on the beginning of page 2 in this document. He expressed his disagreement with this statement being included in the plan. Councillor Byrne stated that he supported Deputy O'Cuiv in this matter. He added that there was no mention of speed limits when Oranmore was being talked about. Mr. Callagy stated that these are suggested options and the land use transportation study will look at all options. It was necessary to prepare a plan and you must have design populations set down.

## PAGE NO. 2 MINUTES OF SPECIAL MEETING HELD ON 21/08/95

He added that public demand will dictate the rate at which Oranmore develops and what the Council was doing was facilitating future growth. Deputy O'Cuiv stated that in facilitating future growth this involved population movement. Councillor Quinn questioned why was one area picked out where people were moved into it. She stated that she did not agree with crowding people into the city and also expressed her disagreement with the restricted area around Galway City. She added that families can be brought up better in rural area. Mr. Callagy stated that Oranmore needed a development plan and that there was nothing wrong with planning for this area. This would not entail requirements that people should move into this area. He added that the paragraph refers only to Oranmore. Deputy O'Cuiv stated that he did not agree that it referred only to Oranmore and could not understand where the figure mentioned came from. Deputy McCormack stated that the Council could not put people into Oranmore if they did not want to move there. He expressed his approval for the sewerage scheme in Oranmore. Deputy O'Cuiv proposed that the first paragraph on page 2 be removed. Councillor Loughnane stated that the sewerage scheme for Oranmore was inadequately designed as it did not cater for Frenchfort. He added that it does not cover existing villages. Deputy McCormack stated that this was only an objective and that it was not telling people where to live. The council has to cater for development in the Oranmore area. Councillor Quinn seconded Deputy O'Cuiv's proposal. Deputy McCormack stated that there was nothing wrong with the paragraph. Mr. Callagy stated that this was only an objective and that you have to plan for areas where development was going to take place. He added that he did not see how planning for Oranmore undermines peoples request to live elsewhere and that nothing would be gained by leaving this paragraph out. Deputy O'Cuiv stated that he objected to design population figures and to this statement. This statement relates to communities in general. Councillor Brennan wished to know if by leaving this statement out what effect will it have on the plan. Mr. Callagy stated that if you are preparing a plan you must prepare it around a population figure. Councillor Joe Burke stated that all the members agreed that a plan for Oranmore is necessary, but the fear is that people will be put into Oranmore. Mr. Callagy stated that a plan for Oranmore was required and recently permission has been refused for 100 houses because of the lack of services in the area. Councillor Loughnane stated that there was no point in having the clause which referred to the population of Oranmore. Deputy O'Cuiv stated that this was a broad sweeping statement and would be thrown back at the members as the method and way to develop.

## PAGE NO. 3 MINUTES OF SPECIAL MEETING HELD ON 21/08/95

This statement refers to all communities he added. Councillor Finnegan stated that it should clearly indicate that this statement refers only to Oranmore. He felt that it did not make a difference whether it was included in the draft plan or not. Councillor O'Byrne suggested that strategies 1, 2 and 3 be stated, but that the comments following strategy 3 be left out. This was agreed by the members. Councillor Gavin referring to the land use transportation study requested to know at what date it would be available and what was the time scale. Mr. Callagy then proceeded to discuss reference 6.2.2, which relates to satellite towns. He stated that plans were not hard and fast documents - they could be varied. He then referred to the population quoted in table 6(a) and stated that these were possible objectives and proceeded to go through the table. Councillor Loughnane stated that there was a requirement that plans be prepared for Clarinbridge and Craughwell. He added that there is a huge demand for houses in these locations and that the demand was for individual houses. He proposed that Craughwell be included in the table mentioned. Councillor Joe Burke referring to Turloughmore stated that this area was entitled to be developed. Mr. Callagy informed the members that Craughwell was not a satellite village, but that it was included in the chapter under villages which are situated on national primary roads. Councillor Byrne stated that two of the villages mentioned in table 6(a) come within the City environs, i.e. Clarinbridge and Oranmore. He was advised that Galway City environs does not include villages. Deputy O'Cuiv referred to the population of towns such as Loughrea, Gort, Athenry. He stated that the plan was providing for a 12,000 increase in the population of satellite towns. This would be at the expensive of the population of the rest of the county and it was going totally against national policy. Deputy Connaughton stated that he assumed planners see a much bigger Galway City. Was there something that can be put in place to balance this development as other areas should benefit also. Can peoples views be changed in where they want to live and in this instance he referred to the district electoral division of Glenamaddy which is declining in population. Mr. Callagy stated that to effect growth of villages then ribbon development must be reduced and services provided in the villages. He added that the public infrastructure was the biggest expense in maintaining a City. The Land Use Transportation Study will address such issues. Deputy McCormack stated that you cannot increase the population of a town without providing services and requested to know where such centres are mentioned in the County Development Plan, does this strengthen their case for the provision of services and funding.

Deputy O'Cuiv stated that he believed that it did advance such centres, but at a price.

## PAGE NO. 4 MINUTES OF SPECIAL MEETING HELD ON 21/08/95

He added that the transfer of populations was regulated by the provision of services and argued that the centralisation of services was no longer necessary. He stated that millions were being put into infrastructure in the Dublin area, services should be put into villages as they now stand. There should not be a requirement that the population in those villages increases in order to acquire such services. Mr. Callagy stated that the objective was to prepare a plan for these areas and added that too much was being read into this table. The fact that a plan is prepared will not prejudice other places. He added that the Council was providing for growth in a planned way. Councillor Loughnane referring to Craughwell requested the preparation of a plan for this village and its inclusion in the County Development Plan. Mr. Callagy informed the Councillor that this village was listed for the preparation of a plan which was included in another chapter. Councillor Loughnané proposed that the village be added to the list included in table 6(a). The Councillor restated that economics are dictated by Government Policy and resources are being put into centres. He added that small communities in peripheral areas must be acknowledged. Deputy O'Cuiv stated that if the services are put into an area, then the developers will build there. He proposed that no population figures be indicated for Barna or Spiddal. Councillor Gavin stated that it cannot leave out population figures and plan for an area. A plan must be realistic and he added that the Barna people want such a document prepared for their area. Mr. Callagy stated that the members can make a decision that the plan does not provide for the growth of Barna or Spiddal. Deputy Connaughton stated that people are more likely to want to live in Barna than for instance Mountbellew and there must be some kind of plan in place for the development of these areas. Mr. Callagy then referred to Section 6.3 which dealt with the zoning of satellite villages. It was proposed by Deputy O'Cuiv that this topic be concluded at the Area Committee meetings and following this that it be brought back to the Council for discussion. This proposal was seconded by Councillor Loughnane.

#### An Gaeltacht

Mr. Callagy preceded to go through the document which was circulated to the members and dealt with the chapter on the Gaeltacht. The introduction to the chapter was agreed by the members. Mr. Callagy then dealt with the physical identity of the area and in particular the architecture. Councillor O'Neill wanted to know was the Planning Authority advising the public of the plans mentioned. He was advised that these documents were included in the County Development Plan. Deputy O'Cuiv stated that he did not see the relevance of including architecture in this chapter.

## PAGE NO. 5 MINUTES OF SPECIAL MEETING HELD ON 21/08/95

It had no effect on the linguistic nature of the area and should be removed. Deputy Connaughton acknowledged the fact that the building of a house will be carried out by persons who want their particular type of plan of house. He wished to know if there could be positive discrimination in order to change the types of house designs. Mr. Callagy stated that the objective was to have a good design and that the design and siting of houses in the Gaeltacht area was a disaster. He reiterated that the duty of the Planning Authority was to promote good design and in speaking about positive discrimination this would relate to grants. Deputy O'Cuiv refuted the implication that as a Councillor he was not interested in design. He stated that he could not see the huge architectural difference between Carna and Renville in Oranmore. He felt that this topic on architecture should be included in chapter 9 and that there was no particular architecture associated with the Gaeltacht area. He agreed with Mr. Callagy that in Connemara in general there is a need for design and siting of houses, but this should be concluded in the Amenity chapter. He proposed that the paragraph on architecture be included in chapter 9. This proposal was seconded by Councillor Byrne. Councillor Byrne expressed his agreement with Mr. Callagy in that in relation to design of houses, which he felt were poor. Mr. Callagy stated that this chapter was there to improve the area and that poor architecture detracts from such locations. Deputy O'Cuiv stated that he only wanted the chapter to address the linguistic aspects of the Gaeltacht. Mr. Callagy informed the members that this County Development Plan was a land use plan and that it was the objective of the Planning Authority to promote good design.

Deputy O'Cuiv proposed that a development objective be specific to the Gaeltacht and referred to his submission. He stated that all major planning developments in the Gaeltacht should be subject to a language impact study. This would for instance relate to a large scale housing scheme. Councillor Gavin expressed his agreement with Deputy O'Cuiv on this matter. He stated that such areas as Claregalway and Annaghdown had the same standing in the Gaeltacht as Carraroe and that the impact of development would vary in these areas. Mr. Callagy stated that he had no difficulty with Deputy O'Cuiv's submission. He stated that major developments should refer to major commercial development. Deputy O'Cuiv proposed that (i). the statement of effect on language and (ii) planning authority would consider this statement in dealing with planning applications. The Council agreed to leave architecture in the chapter on the Gaeltacht. Mr. Callagy then dealt with item no. 2 on the Gaeltacht chapter which referred to signage.

## PAGE NO. 6 MINUTES OF SPECIAL MEETING HELD ON 21/08/95

Councillor Gavin stated that there was a clear difference between Gaeltacht and non Gaeltacht areas. In referring to 2(b) he requested that the words "as far as practical" be included in the statement. Deputy O'Cuiv stated that this should be "where appropriate". This was agreed by the members. On referring to 2(c)(ii), Development Sectors, the Council agreed to include Moycullen and Barna under this heading.

## Chapter 7 - Rural Areas

Mr. Callagy proceeded to deal with chapter 7 which relates to rural areas. Deputy O'Cuiv proposed that under 7.0 on the definition, the following wording should be used "The areas comprise all lands in the county excluding urban areas as described hereunder". This proposal was seconded by Councillor Gavin. Deputy Connaughton stated that he had an interest in 7.0 (c) on development within the speed limits and referred to the National Roads Authority and their decision on the recent speed limits throughout the county. He stated that people were being left in limbo and that there was no reason that planning permission should be refused within the forty mile speed limit. He proposed that the forty mile speed limit replace the thirty mile speed limit and in this way people will be enticed to live within villages. He then spoke on the position of Mountbellew in relation to existing speed limits. The proposal was seconded by Councillor Cunningham. Mr. Callagy stated that this was bad planning and would lead to an increase in ribbon development. Councillor Byrne stated that this did not go far enough in certain towns and villages.

Deputy Connaughton stated that the National Roads Authority were making decisions outside of the bounds of the local community. He added that the Council were trying to get people to live in towns and villages and in turn will not extend speed limits. Councillor Gavin referring to the definition on page I stated that this was too narrow. He seconded Deputy O'Cuiv's submission. The Council members agreed with the change suggested by Deputy O'Cuiv. Section 7.1 which dealt with the main aims such as infrastructure, assimilation of development to public safety and environmental protection, was agreed by the members. Section 7.2.1 which dealt with urban sprawl was then discussed. Councillor Brennan referring to the definition essential housing need stated that the son and daughter requirement was too restrictive and he suggested that nephew and niece should also be included in this definition. Councillor Byrne's suggested that son or daughter of an emigrant would be more favourable.

Mr. Callagy clarified the matter and stated that the Council were only talking about the area within the environs of Galway City and that development control should be kept as tight as possible. If all exceptions were included then the Council would have no plan. Deputy McCormack requested to know how this area compared with the Galway City Development Plan. Deputy Connaughton referring to Councillor Brennan's comments wished to know would an inheritor be entitled to build on land. Deputy O'Cuiv referred to cases where nephews or nieces take care of uncles or aunts and he proposed that "son and daughter" be replaced by "a close relative". Councillor Byrne stated that because of the restrictions there would be no developments on the land other than the essential housing needs category. Referring to page 2 and the statement under areas of Special Development Control commencing with "Residential development shall be restricted to the essential family housing need category", he stated that this would cause problems and restrict development. He requested that it be looked at. Mr. Callagy stated that the definition could be widened to "Son/Daughter or Heir". He recommended that the definition be kept as tight as possible. Councillor Byrne suggested that they defer the discussion on residential development at the moment. Mr. Callagy then referred to the paragraph on cluster development and stated that it related to development within 0.5 miles from national schools. He referred to the 100 feet road frontage requirement. He stated that this was a minimum standard. Councillor O'Sullivan was advised that the road frontage was related to the septic tank requirements in accordance to SR6. Mr. Callagy informed the members that the plan would be inoperable if there was no minimum site frontage. Deputy O'Cuiv referring to minimum site sizes stated that he opposed arbitrary sizes and that each septic tank application should be treated on its merits rather than have minimum requirements.

Deputy Connaughton referring to cases where an applicant had only eighty feet road frontage was there any provision to cater for this instance. Mr. Liam Kavanagh, Senior Executive Engineer, referred to septic tank minimum requirements and site size. He stated that the Department of the Environment insists that all planning applications comply with the SR6. He then referred to an example where the minimum road frontage was not adhered to and the difficulties it had caused. By reading the County Development Plan you must be in a position to know if you are able to get planning permission or not. Councillor Burke stated that 100 feet road frontage should be allowed, but there should be some discretion.

Councillor McHugh stated that there were people advising clients on the basis of the County Development Plan and that you have to be aware that it is a plan for the County. Professionals are studying this plan and require a clear statement of policy from it. The public must be aware of the planning requirements and know where they stand. Mr. Callagy then referred to 7.2.9. on site requirements and stated that under item no. 3, exceptional cases could be considered. Deputy O'Cuiv stated that he agreed with Councillor McHugh that there should be no grey areas in the plan. The meeting then concluded.

CHAPTER 3 - Roads Sanitary Services & Amenity Development

Deputy O'Cuiv referred to 3.1.3. He stated that it was important to include that local roads are for local people. He proposed to add social activities and the benefits for local quality of life to the sentence. This was agreed by the Council.

The County Manager referring to the last paragraph under road classification on page 1 stated that this required rewording.

Deputy O'Cuiv requested that the second last line on page 2 under reference 3.1.3 be deleted. This was agreed by the members. Referring to 3.1.3.(ii), the Deputy stated that there should be a statement that the Council look for money for small sections on National Primary Routes.

Cllr. Burke referred to the disgraceful state of the National Primary Road from Tuam to Ballindine on the Mayo border.

Cllr. O'Neachtain referred to the prioritisation of projects and asked was Kilclooney first on the priority list. He requested that (a) and (b) on page 3 under the Galway/Sligo Road N17 be reversed.

The County Engineer informed the meeting that the fact that the dual carriageway is mentioned does not detract from other projects which the County Council undertake. He added that the road works at Kilclooney were at an advanced stage of planning.

Cllr. Burke stated that during the last 8 years no finance had been provided for Kilclooney and added that more money was being put into design rather than roads. He wanted Kilchoney to be first on the priority list for the N17.

The County Manager stated that he did not agree that more money was being put into design rather than actual road works.

Cllr. Burke replied that the neighbouring County of Mayo had carried out works on miles of roads.

Deputy O'Cuiv proposed (a) and (b) be reversed in order and this was agreed by the Council. He then referred to the Lydican stretch of road and requested that this be mentioned in the document. This was agreed by the Council. The Deputy then referred to the National Secondary Roads under 3.1.3 (ii) and requested that the following sentence be amended to include "towns on it". The sentence in question being "it serves the towns, villages of etc". There should also be an objective included in the plan to seek funding.

The County Manager stated that the sentence on funding could be included under 3.1.1. This was agreed by the members.

Cllr. O'Neachtain referred to the negative aspect of 3.1.3 (ii) under National Secondary Roads and in relation to the funding he requested that the statement commencing "little funding has been provided etc." be reworded to reflect a more positive view point.

Cllr. Loughnane stated that there should be a statement in the plan that funding would be sought for the N66 and the N67 National Secondary Roads.

Deputy O'Cuiv referring to the National Roads Plan stated that funding should be sought to complete the objectives set out in this Plan.

Cllr. Finnegan stated that the Tuam/Dunmore Road should also be mentioned, especially the dangerous road at Brownsgrove.

The County Engineer referred to the state of the National Secondary Road. He spoke on the procedure in dealing with road works and stated that road design money was first required to design the particular projects over a time-scale of approximately 2 years. It then would take two further years to complete the job in question. The County Council have not received finance for the design of roads over the last number of years.

Deputy O'Cuiv stated that there was work required on National Secondary Roads which did not require major design money.

Cllr. Finnegan requested that the stretch of road at Brownsgrove be mentioned in the plan.

The County Engineer stated that all dangerous road areas are highlighted each year in a submission to the Department. He further added that the CPO procedure is a delay which must be taken into account when dealing with road works. Government policy directs that funding goes into National Primary Routes rather than Secondary Roads.

Cllr. O'Neachtain stated that the R336 should not be a regional route because of the heavy volume of traffic. This road should not be confined to a regional status and must be looked at urgently. It required that it be replaced and given a specific mention in the plan, the road serves the whole west area of the County and requires to be a priority. He added that upgrading the route would be impossible and it should be mentioned that a new road is

required.

Deputy O'Cuiv in supporting Cllr. O'Neachtain stated that regional and local roads should be dealt with in line with the 5 year plan.

The County Engineer referring to the R336 stated that it was a grossly overloaded road and that he would agree with the Councillors in this respect. Of all the regional roads in the County it is certainly the most heavy trafficked and extremely dangerous. A line has been selected for a new route replacing the existing road but further details and research will have to go into this project. He added that a land use transportation study is presently being prepared and the Council is awaiting its report.

Cllr. O'Neachtain stated that more emphasis must be put on the R336 and requested that a statement be included in the plan. This was agreed by the members.

Cllr. J. Burke asked how the County Council would be represented on the land transportation study.

The County Manager stated that it was a joint operation between the County Council and Galway Corporation.

The County Engineer and City Engineer together with senior planning officers from each local authority would form part of the group.

Deputy O'Cuiv welcomed the funding received for the study. He then spoke on the proposed bridge over the Corrib. He requested that all projects for bridges over the Corrib be mentioned and not one specific job.

Deputy McCormack stated that the bridge he had in mind was in Kilbeg/Knockferry which he felt required more priority. He added that there was no real commitment from the Council towards the provision of this bridge.

The County Engineer stated that the present bridge over the Corrib is almost up to capacity at the present moment. A further bridge would link the west and east of the County and would avoid traffic coming into the City centre. Its purpose would be to deal with the County traffic. Such a route must now be identified and included as an aspiration in the County Development Plan. Referring to the Kilbeg/Knockferry proposed bridge, he stated that on the cost benefit analysis this application did not stand up to scrutiny.

Deputy Cormack requested that the proposed Kilbeg/Knockferry bridge be addressed.

Deputy Connaughton referring to the requirement for a further bridge over the Corrib requested to know if a new road network would be put in place. He put the question, should traffic be intercepted at a proposed bridge at Knockferry.

The County Engineer stated that traffic volumes did not justify a bridge at Knockferry/Kilbeg. A further bridge in the City would have to have an attendant road network and that the County Council must plan for the future. All options would be looked at including the Kilbeg/Knockferry project but he added that every project was subject to cost benefit analysis.

Deputy O'Cuiv stated that he accepted what the County Engineer had outlined but he did not agree with the wording in the draft plan for the transportation study. He wanted a balance to be included in the statement.

Cllr. Varley referring to the proposed bridge at Kilbeg stated that it would take the volume of traffic away from the City.

Cllr. O'Neachtain concurred with the County Engineer. He would like to see the wording used for this study changed and agreed with Deputy O'Cuiv on this matter. He realises the importance of the land use transportation study.

Mr. Callagy stated that the reason it is emphasised is that it is a roads objective.

Cllr. Loughnane asked at what stage was a line reserved for a proposed bridge and would this be incorporated into the plan. He was advised that this was merely a statement and that a new bridge was required for crossing the Corrib.

The County Engineer stated that the Council have been looking for possible locations and will finally select one when the transportation study is produced.

Cllr. J. Burke asked if the proposed bridge for Kilbeg/Knockferry was included in the study.

The County Engineer advised that all crossings of the Corrib would be considered.

Deputy McCormack stated that he wanted the proposed bridge for Kilbeg/Knockferry included as an objective in the County Development Plan and added that he supported the financing of an up to date study on this project.

Cllr. J. Burke asked what was the time-scale involved.

Deputy O'Cuiv asked if this procedure could be written into the County Development Plan.

The members then agreed with the contents of chapter 4. app.

### CHAPTER 5 - HOUSING & COMMUNITY FACILITIES

In relation to 5.1.1 objectives headed public housing Deputy O'Cuiv proposed the insertion of the following as item (e) "the elimination of demountable dwellings". This was supported by Cllr. Mullins.

The Chairman requested that the words "phase out" instead of eliminated be used. This was agreed.

Deputy O'Cuiv referred to 5.1.2 (5) (2) which dealt with the demand for houses in urban areas. He stated that he was not in agreement with this statement and

requested that it be deleted. This was agreed. The item on specific objective was also agreed to be omitted under this heading. The remainder of 5.1.2. was agreed. Deputy O'Cuiv referring to 5.3 on private housing stated that the development of Oranmore would end up as a mini Tallaght.

Cllr. Loughnane stated that there were other towns where there was demand for housing and people in these towns were finding it difficult to get sites within the town boundaries. He requested the inclusion of a statement of the need for development sites within certain towns. He added that it would be desirable to have an objective in the plan to grant planning permission within 3 to 4 miles of the town boundaries.

Mr. Callagy stated that he would research this matter and refer back to the Council.

Cllr. Loughnane stated that planning permission has been refused in the Loughrea area for the flimsiest reasons.

Cllr. Varley suggested that the County Council buy derelict sites located in towns and villages. It was agreed to delete the last sentence in the paragraph on private housing.

Deputy O'Cuiv then referred to the fire services and spoke on the fire services requirement in Inishmaan, Inishmore and Inishbofin. He requested that they be included as objectives. This was agreed by the members.

### CHAPTER 6 - LAND USE PLANNING

Under 6.1. on scheduled towns, Deputy O'Cuiv referring to the statement on urban sprawl expressed his disagreement with the wording.

He was advised by Mr. Callagy that the County Council has been unable to control urban sprawl.

Deputy O'Cuiv proposed that the statement be changed and added that the problem with sprawl is the growth of Galway City and not the lack of controls.

Cllr. J. Burke stated that they should have a more positive statement included instead.

Mr. Callagy replied that the basic principle was to separate town and country and to preserve the rural landscape.

Deputy O'Cuiv referring to the growth of Galway City stated that urban sprawl existed around all cities.

Mr. Callagy then referred to 6.2.1 which deals with the long term growth of Galway City environs and

spoke on the three strategies outlined. He added that strategy no. 2 was the best option.

Deputy O'Cuiv stated that the members know the demographic trend of Galway City, rural areas are declining and if Galway City continues growing, there will be little left in the rest of the County.

Cllr. J. Burke expressed his agreement with Deputy O'Cuiv and stated that the development plan should not supervise the decline of County Galway.

Cllr. O'Neachtain stated that there must be a good liaison between the Corporation and the County Council. He then referred to Barna and stated that infrastructure must also be provided in this area. He added that Galway City was increasing at an uncontrollable rate.

Cllr. Loughnane stated that he made a submission to have positive plans for villages. A plan for smaller towns should be included. The Council must deal with areas of the County which are dying from depopulation.

Deputy O'Cuiv referring to 6.2.1 stated that there should be an objective in the plan that Galway City does not expand at the expense of the County and proposed that this be included as an objective in the County Development Plan. This was seconded by Cllr. Loughnane.

Deputy McCormack stated that the Council could have plans for Oranmore and Barna which are situated in the County area but what happens in the borough is not their decision.

Cllr. Brennan stated that if people want to move into the borough, it is their choice.

Cllr. Finnegan stated that if the objective outlined in strategy 2 is followed, then a new bridge over the Corrib would not be required.

Deputy O'Cuiv stated that it is the policy to create growth centres and that most jobs are generated by state activity e.g. health, education, and government agencies; these are the greatest creator of urban development and people live where the jobs are.

Cllr. O'Neachtain stated that the long term strategy must be a joint exercise being Galway Corporation and Galway County Council.

6.1. was agreed subject to the re-phasing of the last sentence. It was decided that the phrase recommending strategy 2 be omitted.

Mr. Callagy advised the members that a statement would be inserted in this document stating that

Galway City should not grow at the expense of the County.

Referring to 6.2.2 on satellite villages, Cllr. O'Neachtain requested the re-phasing of this paragraph in order to protect the County area from the growth of Galway City.

Deputy O'Cuiv stated that if Spiddal is included under this heading then the Gaeltacht area will be destroyed. It would lead to people coming from outside.

Cllr. O'Neachtain stated the villages must be protected as they have a character of their own.

Deputy O'Cuiv added that if a major development is proposed for Spiddal them this will result in the loss of the language in the area.

Cllr. O'Neachtain stated that the growth of Spiddal village had to be controlled and that it was their preference that the cultural entity be maintained rather than it be turned into a satellite village.

Mr. Callagy stated that it was agreeable to change the long term date with existing growth level.

Cllr. Gavin asked if the Council were allowing development to take place without sufficient services being available and in this instance he referred to Moycullen which had a problem with the sewerage system.

Mr. Callagy then referred to a zoning map which was being circulated to the members and dealt with zoning of Oranmore village. He then proceeded to go through the zoned towns within the County area.

Deputy O'Cuiv proposed that the town zoned plans be dealt with at a later meeting and this was agreed by the members. The contents on the Environs of Tuam and Loughrea under 6.3 was agreed.

Deputy O'Cuiv requested clarification on 6.4.2 which provides for the growth of areas with planned boundaries of Furbo, Knock and Ballinahown. What was their designation.

Mr. Callagy stated that the village boundaries outlined the area within which community facilities could be built and this proposal was then agreed by the members.

On 6.5 villages on national routes Mr. Callagy spoke on this topic, the contents of which were agreed by the members.

6.6. which deals with civic amenity planning was agreed by the members.

Deputy O'Cuiv then spoke on the details relating to the maximum size of school population requirements as detailed on page 2 of the document. He made a proposal that this paragraph be removed.

Mr. Callagy expressed his strong objection to its removal and stated that there are standards which must be used in calculating planning targets.

Deputy O'Cuiv added that he did not agree with design type population.
