## **Minutes of Meeting of Joint Policing Committee**

Held on Monday 27th June, 2011

The Prayer was recited.

The Minutes of meeting held on Monday 8<sup>th</sup> November, 2010 were adopted on the proposal of Councillor Reilly seconded by Councillor Kelly.

The Mayor welcomed Senator Higgins to her first J. P. C. Meeting.

## **Matters arising from Minutes**:

It was proposed by Councillor Reilly and seconded by Councillor Kelly that the Traffic Lights at the N17/Ballygaddy Road and N17/Weir Road junctions be replaced by roundabouts. Councillor Reilly called on the County Council to acquire a property at the Weir Road junction to construct a roundabout. Councillor Kitt and Councillor Flanagan queried the suitability of a roundabout at Weir Road while Sergeant Connor said the staggered nature of the junction at Weir Road meant a roundabout would not be suitable. Supt. Begley stated that the problem was the volume of traffic traveling through a small space. He suggested that a scientific/safety survey be carried out before any change is made.

The Manager stated that uncontrolled junctions would be a hazard for Pedestrians, cyclists etc. and may not be the appropriate solution. He said the Traffic Lights will be upgraded and synchronised when work on the N17 is completed and this should lead to improved traffic flow.

Following further discussion the proposal was withdrawn and the Town Engineer agreed to check surveys carried out at both junctions.

### **C.C.T.V.:**

Replying to Councillor Reilly Inspector O'Dwyer stated that a new location has been identified for the proposed extra camera at the Square. RAPID are dealing with this. Mr. Gilmore stated that the Housing Unit, Galway County Council also proposed to erect a camera at Gilmartin Road. Replying to the Members Supt. Begley said the quality of footage from the cameras was dependent on factors such as light and weather. C.C.T.V. on its own does not prove everything, it is a deterrent and a preventative tool, evidence from witnesses is still the most important aspect of crime prevention. Replying to the Members Mr. Gilmore said the C.C.T.V. cameras in Tuam are not infra-red. He also said maintenance work had been carried out on the cameras in the past month. It was proposed by Councillor O'Grady, seconded by Councillor Reilly and agreed that a C.C.T.V. camera be installed on the road to the Palace Grounds.

## Tuam Town Water Distribution and Main Drain Scheme:

Councillor Bane asked if free parking could be made available in Tuam in order to get People into the town. Senator Higgins stated that Business People in other towns had also suggested half an hour to one hour of free parking in an effort to encourage more people into the centre of towns. Councillor Kelly felt unlimited free parking would be abused. Councillor Kitt suggested limiting free parking to Saturdays as the present system where people can park for a short time for 20 cents is working well. Councillor O'Grady said the provision of more parking spaces was the issue and called on parking areas at the Grove and the Schools etc to be made available.

Mr. Gilmore said free parking would deny Galway County Council of revenue at a time when services are being curtailed due to lack of funding. He said traffic income is down throughout the county while expenses are static. Parking is a problem in all towns. Galway County Council will look at traffic charges if requested to do so.

#### **A.O.B.:**

Replying to Councillor Reilly regarding the lack of new Gardai Recruits Supt. Begley said the Gardai Siochana will always endeavour to do their best with available resources and provide a service to the People.

## Minutes of Monthly Meeting held on Monday 4th July, 2011

The Prayer was recited.

The Minutes of Monthly Meeting held on Monday, 13<sup>th</sup> June, 2011 was adopted on the proposal of Councillor Reilly seconded by Councillor Kelly. The Minutes of Annual Meeting held on 13<sup>th</sup> June, 2011 was adopted on the proposal of Councillor Flanagan seconded by Councillor Reilly.

Councillor O'Grady congratulated Mr. Kevin O'Sullivan, formally of the Tuam Herald, on his appointment as Editor of the Irish Times.

### **Matters arising from the Minutes:**

Replying to Councillor Reilly the Town Clerk said Mr. Fiachra Quigley, Provincial Sales Manager, Bord Gais would attend the September meeting of the Board. Replying to Councillor O'Grady regarding rumours that High Street would have to be dug up again the Town Engineer said Bord Gais was on board from the start of the Tuam Water Distribution and Main Drainage Scheme and only 'pits' to gain access to the ducts already laid will be dug. Disruption will be minimal.

Regarding Rates Councillor Flanagan told the Members Councillor Bane was unable to attend the meeting because of a family bereavement. She read letter dated 29<sup>th</sup> June, 2011 from the Minister for Environment, Community & Local Government.

It was proposed by Councillor Kelly, seconded by Councillor Reilly and agreed to deal with applications for funding under the "Contribution to the Arts" at the end of the Meeting.

Replying to Councillor Ward who stated that there was no emergency service in the town at weekends the Town Engineer said this had been highlighted and the Town Manager had agreed to clarify the situation. He agreed to raise the matter with the Manager.

Councillor Reilly asked that the new income threshold for Local Authority houses be discussed. Councillor Ward said the new Social Housing Assessment Regulations 2011 are discriminatory and are an infringement of Article 40 of the Constitution. It was agreed to include the matter on the agenda for the September meeting also to invite the Tuam Electoral Area Councillors to a special meeting.

The Mayor welcomed Deputy Kitt, Deputy Keaveney and Senator Higgins to the Meeting.

<u>Industry and Employment</u>: Deputy Keaveney said the consumer collapse had been ten times greater in Ireland that in any country. Costs: rates, rents etc. are a major issue. Legislation is imminent in relation to upward only rents and reliefs to the retail sector. It is hoped the new rates of vat and prsi will drive job creation.

Deputy Kitt said Companies are retaining jobs in Tuam. He supports the Duffy/Walsh report. He said he would like to see support for Galway Airport.

Senator Higgins said she had not been a member of the Oireachtas at the time of the last meeting. High rates have a knock-on effect and she hoped to tackle this in the Senate. It is important to try and facilitate businesses to stay open.

M17/M18 and Tuam By-pass: Deputy Keaveney said he had been in contact with the Minister for Transport. This road is part of the programme for Government, discussions are continuing and proposals are being considered. It is hoped to have more details in September.

Councillor Kitt stated that the N. R. A. had met with the preferred bidders and land acquisition is going ahead.

Senator Higgins said she fully supports the M17/18 and Tuam by-pass.

#### Western Rail Corridor:

Deputy Kitt said there had been 250,000 journeys from Galway to Limerick and this is very encouraging. Improvement to the timetable is being looked at. A review of prices is also taking place and this should be complete by September. Crusheen and Oranmore stations will be open next year.

Deputy Keaveney said he had met with the Minister and 'West on Track' and the consensus is to maintain the project and he hopes to see the Athenry to Tuam section opened in the future.

Ambulance Base: Councillor Reilly told the Members the Ambulance Base has gone to Tender. The Tender process should be completed by September and it is hoped construction will commence then. He paid tribute to the Order of Malta who have provided an excellent service in Tuam over the years.

<u>Fuel prices</u>: Councillor Flanagan stated that the variation in fuel prices has been discussed at a number of Town Council meetings. The Department of Transport has been contacted and is monitoring Tuam, prices have dropped noticeably.

V. E. C.: Senator Higgins told the Members the Headquarters of the County Galway V.E.C. was located in Athenry. She would be calling on the Minister to keep the V.E.C. Headquarters of the newly amalgamated Galway/Roscommon V.E.C. in Athenry as this would be close to Roscommon town and Galway City. The members supported this.

### Correspondence:

The following letters were read, noted and agreed:

Letter dated 20<sup>th</sup> June, 2011 from Ms. Sara Lane, Pat Lane Shoes Ltd., regarding parking at Shop Street. It was agreed to write to Ms. Lane and inform her that the matter is discussed regularly by the Town Council but nothing can be done until the Tuam Water Distribution and Main Drainage Scheme is completed.

Letter dated 27<sup>th</sup> June, 2011 from Mr. Kevin Kelly, Director of Services – read.

Letter dated 14<sup>th</sup> June, 2011 from Mr. Albert Comer, SEO Planning & Sustainable Development Unit, Galway County Council. It was proposed by Councillor Kelly, seconded by Councillor Reilly and agreed the Mayor attend the County Galway Joint Policing Committee Workshop.

## **Tuam Water Distribution and Main Drainage Scheme:**

Councillor Flanagan told the Members she had been contacted by Mr. Dermot Collins, Project Engineer that evening to state he was unable to attend the meeting. It is expected work at Shop Street will be completed on 15<sup>th</sup> July. Work on Bishop Street may not start until September.

#### **Memorial Plaque:**

Councillor Ward presented quotation for cost of erecting a Memorial Plaque on the Town Hall in memory of all who died in all wars. It was proposed by the Mayor, seconded by Councillor Reilly and agreed that the plaque be erected on the exterior front wall of the Town Hall, the cost of E500-00 be paid from the Town Enhancement fund. It was proposed by Councillor Reilly, seconded by Councillor Flanagan and agreed to write to Ms. Mairin Doddy, Conservation Officer.

Councillor O'Grady told the Members a commemorative ceremony would be held in N. U. I. G. on Sunday 10<sup>th</sup> July for all who joined the British Army. A Military Historian will be in attendance.

## **Tuam Athletic Club:**

Letter from Mr. Brendan Monaghan, Secretary, Tuam Athletic Club which was read at meeting held on 13<sup>th</sup> June, 2011 was discussed. Councillor O'Grady said Galway County Council own land at Weir Road. He proposed that the Astro-turf pitches be located there, public ground, and the Athletic Club may also be accommodated there. Letter dated 22<sup>nd</sup> June, 2011 from Deputy Kitt was also read. The Mayor stated that Tuam Celtic had applied to have the Astro-turf pitches located at their grounds. It was proposed by Councillor Reilly, seconded by the Mayor and agreed to write to Mr. Monaghan and state that the proposal will be considered.

## **Contribution to the Arts:**

It was proposed by Councillor Kelly, seconded by Councillor Flanagan and agreed to allocate E1,000-00 to Tuam Youth Theatre, E300-00 to Map of the City of Tuam by John Bourke and E200-00 to Dr. Matthew Potter, The Municipal Revolution in Ireland Book.

#### **A.** O. B.:

Councillor Reilly told the Members he had been approached by People who had received litter fines after leaving bottles at the bottle bank on the Weir Road. He called on Galway County Council to erect appropriate signs at the bottle bank. He also said the phone number advertised is out of order.

Regarding a bench at Parkmore Estate the Mayor asked the Town Engineer to talk to Residents in the area before the bench is refurbished.

Councillor Ward stated that the Tuam Cemetery Committee – Councillor Ward, Councillor Kelly, Councillor Flanagan, Councillor O'Grady, and Councillor Reilly- had met with the Town Engineer.

The cost of repairs to the Gates, ironwork etc. is estimated to be E40,000-00. He proposed setting up a group through the T.U.S. programme operated by Galway Rural Development which would allow unemployed people apply to be included in refurbishment work at cemeteries for a twelve month period. Insurance would be covered by Galway Rural Development. Supervision, tools and materials will have to be supplied. Eight cemeteries in the Tuam area could be included in the scheme. Following discussion it was proposed by Councillor Kelly and seconded by Councillor Reilly that E5,000-00 allocated by the Town Council in 2010 for work at the cemetery be used to carry out emergency work.

It was proposed by Councillor Reilly, seconded by the Mayor and agreed to investigate regarding the T.U.S. programme.

It was proposed by Councillor Flanagan, seconded by Councillor Kelly and agreed that the Mayor represent the Town Council at the  $20^{th}$  Anniversary of the twinning of Tuam with Straubing in Straubing in August

It was proposed by Councillor Reilly, seconded by the Mayor and agreed that Arthritis Ireland be given the use of the big room downstairs for their monthly meetings, 1<sup>st</sup> Tuesday of each month, starting in September.

It was proposed by Councillor O'Grady, seconded by Councillor Reilly and agreed to write to Fr. Stephen Farragher and Fr. Ray Flaherty and wish them well in their new assignments.

The Minutes of Special Meeting held on Wednesday, 13<sup>th</sup> April, 2011 was adopted on the proposal of Councillor Reilly seconded by Councillor Kitt. The Minutes of Special Meeting held on Monday 18<sup>th</sup> April, 2011 were adopted on the proposal of Councillor Reilly seconded by Councillor Kelly. The Minutes of Monthly Meeting held on Monday, 9<sup>th</sup> May, 2011 was adopted on the proposal of Councillor Reilly seconded by Councillor Flanagan. The Minutes of Special Meeting held on 16<sup>th</sup> May, 2011 was adopted on the proposal of Councillor Flanagan seconded by Councillor Reilly. The Minutes of second Special Meeting held on16th May, 2011 was adopted on the proposal of the Mayor seconded by Councillor Flanagan.

### **Matters arising from the Minutes:**

Replying to Councillor Bane regarding resurfacing of Ballygaddy Road the Town Engineer said a submission/proposal to resurface 500 meters of road has been sent to the Department. The white line at Dublin Road will be re-instated. Regarding the Traffic Lights he said it was hoped to have the lights re-aligned before September. Regarding site at Weir Road Mr. Gilmore said discussions are taking place.

It was proposed by Councillor Kelly, seconded by Councillor Reilly and agreed to write to Mr. Kevin Kelly, Director of Services, Galway County Council and ask for explanation as to why the old Library building cannot be leased to a voluntary group.

It was proposed by Councillor Flanagan, seconded by Councillor Reilly and agreed to invite the area T. D.s to the July meeting. It was proposed by Councillor Bane, seconded by Councillor Reilly that a special meeting be held.

Replying to Councillor O'Grady the Manager stated that Galway County Council has an active programme for unfinished estates. Following discussion the Mayor said she would contact Senator Higgins with a view to organizing a meeting with Minister Penrose.

Replying to Councillor O'Grady Mr. Gilmore said if somebody wrecks a local authority house they are taken of the housing list. He said there are particular issues and difficulties relating to properties at Gilmartin Road but various initiatives are being brought forward. ## **Election of Mayor:**

The outgoing Mayor thanked everyone for their co-operation during the year. She thanked the Manager, the Engineer, the Town Clerk and the Press for their support. She thanked the Fine Gael Party and Members of the Board. She also thanked her Family and friends. She said it had been a very busy year and it had been a privilege to represent the Town Council at various functions. She wished the in coming Mayor good luck.

She then invited nominations for the position of Mayor. It was proposed by Councillor Reilly and seconded by Councillor Flanagan that Councillor Loftus be elected to hold the office of Mayor of the Town of Tuam for the coming year. There being no other proposal Councillor Loftus was elected. Councillor Loftus took the Chair.

She congratulated the outgoing Mayor on an excellent year. She said she was extremely humbled and honoured to be elected Mayor of Tuam and thanked the Members for electing her. She said she joined the Labour Party in 1979 and was the first Labour Party Mayor of Tuam. This together with the election of Deputy Keaveney to the Dail and the appointment of Senator Higgins to the Seanad is a feat never achieved before by the Labour Party in Galway East. The Minutes of meeting held on 5<sup>th</sup> July, 2010 were adopted on the proposal of Councillor Kitt seconded by Councillor Cunniffe.

#### **Matters arising from Minutes:**

Regarding Crime Statistics Superintendent Begley stated that provisional figures for the Tuam Sub District to 25<sup>th</sup> October, 2010 compared with 2009 showed that Public Order offences decreased by 31 from the previous year. Criminal Damage cases increased by 14 on the previous year, there were 10 instances on one night alone and 4 on another occasion. Thefts were down by 26 while burglaries decreased by 10 when compared with 2009. Replying to Deputy Kitt he said Minor Assaults, 'Section 2', Offences increased by 11 over 2009. Serious Assaults, 'Section 3', Offences - where there is physical damage to a person - were down slightly. Replying to Councillor Loftus he said all public order issues are alcohol related. Replying to Councillor Kitt Inspector O'Dwyer said Garda Hugh Gallagher liaises with the schools and young people - training is taking place at the moment regarding a pilot scheme for secondary schools. The Members welcomed the initiation of five new "Neighbourhood Watch" schemes in the town.

## Tuam Town Water Distribution and Main Drain Scheme:

Councillor Kelly thanked Supt. Begley and the Gardai for the efficient way they responded to a traffic jam earlier in the evening. Councillor Warren asked that Dublin Road –beside St. Patricks School' - be monitored as cars are coming down the one-way system. Councillor Bane asked that the traffic lights at the Old Road/Ballygaddy Road junction be adjusted.

#### A. O. B.:

Replying to the Mayor regarding a vacancy on the Joint Policing Committee Mr. Gilmore said the vacancy will be filled from the Community and Voluntary Sector and this will be done by Galway County Council.

Replying to Councillor Cunniffe regarding monitoring of C.C.T.V. Supt. Begley said the Gardai do not take on monitoring. Monitoring of C.C.T.V. would mean four Gardai having to be taken of street duty, this would be an inefficient use of available resources. The Town Manager stated that C.C.T.V. was funded by the Departments of Communications and Justice and Law Reform and may be used by Gardai post incidents. The monitor is fully accessible to the Gardai and access can be gained very quickly.

Replying to Councillor Ward regarding the installation of speed inhibitors on cars Supt. Begley said that was a matter for legislation.

Supt. Begley told the J. P. C. that the Local Policing Plan for 2011 is being prepared and any suggestions would be welcomed.

It was agreed to hold the next J. P. C. meeting in February 2011.

Consultation must take place between the Roads Unit, Galway County Council, the Water Unit, Galway County Council and Coffey Construction, the Town Engineer and Executive Engineer. The Members unanimously supported 24 hour work at weekends on the N17, O'Connell's to Coca Cola, provided all departments are in agreement. The Members asked that better signs be erected especially at Ballygaddy Road and end of Chapel Lane.



Mr. Gilmore told the Members there was a vacancy on the Corporate Affairs and Cultural SPC following the co-option of Councillor Cunniffe to Galway County Council – letter dated 24<sup>th</sup> March, 2011 from Ms. Breda McDermott, Senior Executive Officer, Corporate Services refers. It was proposed by Councillor Kelly, seconded by Councillor Kitt and agreed that Councillor Reilly represent Tuam Town Council on the SPC.

Regarding the M17/M18 Mr. Gilmore said the development of the P. P. P. project is highly confidential. The NRA is fully committed to the project. E120m has already been invested. It was proposed by Councillor Reilly, seconded by Councillor Loftus and agreed to write to the Taoiseach and Minister for Transport.

#### **Bank Mandate:**

The Town Clerk told the Members that when the Bank mandate was being updated in November, 2009 at item number 4 "any two of above signatures" was ticked instead of "any one of above signatures" which was the case prior to 2009. It was proposed by Councillor Kitt, seconded by Councillor Kelly and agreed that item number 4 on the Bank mandate revert to one signature.

## **Tuam Water Distribution and Main Drainage Scheme:**

The Mayor informed the Members she had contacted Mr. Dermot Collins, Project Engineer prior to the meeting. Work is ongoing on Dublin Road and the Weir Road. Work is continuing at night on the N17, North and South. Church View will be closed next week. Foster Place will re-open on Thursday. A section of Tullinadally Road will be closed from Monday 11<sup>th</sup> April. Shop Street will be closing on 3<sup>rd</sup> May, 2011.

Replying to Councillor Cunniffe who suggested that work on Shop Street might be carried out at night the Manager said he would discuss the matter with the Water Services Unit, Galway County Council.

Replying to Councillor Bane Mr. Gilmore said the traffic lights on the N17 are on manual control at the moment, the installation of an automatic control system will be investigated.

Replying to Councillor Ward the Town Engineer said work on the Purcell road was complete. Councillor Ward asked that a pedestrian crossing be installed at the Railway Kitchen end.

## Water Meters/Frozen pipes:

Mr. Gilmore told the Members that the Celtic Anglian Water Company is responsible for water meters, some of which shattered during the cold spell.

Some meters were replaced and others were repaired. Some meters were installed less than 4 feet below ground – the standard depth for roads is 4 foot. Some new meter boxes will have to be installed. Galway County Council is liaising with the Department of the Environment. Councillor Reilly thanked the County Council for their co-operation during the cold spell. The Mayor asked that the Court Services be contacted with a view to locating re-cycling bins at the car park adjacent to the old Court House.

Alan Kelly was congratulated on his winning of the Junior "West has got Talent" Competition.

The Mayor, Members and Officials paid tribute to Councillor Warren who was attending his last meeting. The Mayor asked that a bell, first erected by the Town Commissioners in 1886 be preserved. It was proposed by the Mayor, seconded by Councillor Reilly and agreed that the bell be cleaned and put on display.

Replying to Councillor Cunniffe regarding the Weir Road Mr. Gilmore said the National Roads Authority is responsible for National Routes and Motorways but also manages road funding allocations for County Councils. Galway County Council provides funding for local and regional roads.

Councillor Warren told the Members he intended to step down from the Board of the Town Council in May 2011. He said because of work and other commitments he would be unable to give 100% to the Town Council. He said he had been a Member of the Board for the past twelve years and thanked everyone for their co-operation.

The Mayor wished everyone a happy new year.

The Minutes of special Meeting held on Wednesday, 24<sup>th</sup> November, 2010 were adopted on the proposal of Councillor Reilly seconded by Councillor Kitt. The Minutes of ordinary meeting held on Monday 6<sup>th</sup> December, 2010 were adopted on the proposal of Councillor Reilly seconded by Councillor Kitt. The Minutes of Budget of Expenses Meeting held on Monday 6<sup>th</sup> December, 2010 were adopted on the proposal of Councillor Reilly seconded by Councillor Kitt. The Minutes of Budget of Expenses Meeting held on Monday 13<sup>th</sup> December, 2010 were adopted on the proposal of Councillor Reilly seconded by Councillor Ward.

## **Matters arising from the Minutes:**

Replying to Councillor Cunniffe the Town Engineer stated that Bicycle Racks were on the way.

Replying to Councillor Kelly regarding later hours at the Library Mr. Gilmore said he had written to Mr. Kevin Kelly, Director of Services.

Replying to Councillor Reilly Mr. Gilmore said the Tuam Water Distribution and Main Drainage Scheme had been delayed by the bad weather. It was proposed by Councillor Bane, seconded by Councillor Reilly and agreed that Mr. Dermot Collins, Project Engineer be invited to the February meeting of the Board.

Councillor Reilly asked that a sign be erected at the car park in Bishop Street indicating the area where parking must be paid for.

Replying to Councillor Ward the Town Engineer said a grit depot had been provided at the Swimming Pool.

## **Correspondence**:

The following letters were read, noted and agreed:

Letter dated 14<sup>th</sup> December, 2010, from Galway County Council re: Invitation of comments in relation to a Wind Energy Strategy for County Galway. – noted Letter dated 23<sup>rd</sup> December, 2010 from Office of Minister for Transport – read. Letter dated 3<sup>rd</sup> January, 2011 from Restaurants Association of Ireland – read.

The Mayor welcomed the positive news from I.B.A.L., Tuam has gone from no. 49 to no 28 on the litter table. He said this was a huge lift to the Town. He appealed to People to clean outside their own premises.

#### **Ambulance Base:**

It was proposed by Councillor Reilly seconded by Councillor Loftus and agreed to invite a Member of the H. S. E. to the next meeting of the Board.

## **Tuam Chamber of Commerce:**

Letter dated 7<sup>th</sup> January, 2011 from Tuam Chamber of Commerce was read. Replying to Councillor Kitt the Manager said Galway County Council took the decision not to reduce the county rate. All money collected in Tuam is spent in Tuam. Tuam has benefited in recent years – a swimming pool which is subsidized, Broad Band Investment, Investment in the Tuam Water Distribution and Main Drainage Scheme. The town rate has been adopted and cannot be revisited.

All Members agreed that discussions and meetings should be held with Tuam Chamber of Commerce. Tuam Town Council fully supports the Chamber of Commerce and agreed more dialogue is needed. It was proposed by Councillor Bane, seconded and agreed that the Chamber of Commerce be invited to the February meeting of the Board.

The Mayor welcomed Mr. Kevin Farrell to the Meeting. Mr. Farrell outlined the problems experienced with frozen pipes and a frozen meter which forced his business to close during the cold spell and asked that something be done to prevent an occurrence of same in the future. He asked if a water meter could be brought into a building. The Members also outlined problems experienced by householders. Councillor Cunniffe asked that pipes be put 'well down' where roads are being dug up. Councillor Reilly paid tribute to Council Staff who worked over Christmas.

Mr. Gilmore said the exceptionally low temperature, -17, caused havoc. Modern very well insulated houses couldn't be heated. Water was rationed in many areas, a helpline set up by Galway County Council logged 186 leaks in one day. Untold damage has been done to roads. Galway County Council had noted the problems with the water meters, the Water Services Division had been asked to investigate. He said he would discuss the situation with Water Services and respond at the next meeting. He paid tribute to staff who worked over Christmas.

#### **Notice of Motion:**

Councillor Ward spoke on his motion regarding multiple pensions. Councillor Kitt stated that this had been discussed by the Government following the last election and multiple pensions will not be paid in future. Legislation dealing with the matter has gone through.

### A. O. B.:

Councillor Cunniffe asked that something be done about dogs littering the footpaths. He also asked that Gilmartin Road be monitored as he had received reports of horses in gardens.

Replying to Councillor Ward regarding Church View the Town Engineer said temporary restoration was being carried out.

Replying to Councillor Bane regarding resurfacing of Ballygaddy Road the Town Engineer said he would have information for the next meeting.

Replying to the Deputy Mayor regarding pot holes the Town Engineer said it would be two to three weeks before inside the speed limits are dealt with as work is continuing on main roads.

Replying to Councillor Reilly Mr. Gilmore said he was hopeful that the contract for the Tuam By-pass and the Tuam to Gort road would be signed this month.

Following further discussion Councillor Reilly said the proposed layout as presented to the Board was not acceptable and proposed that a decision on the matter be deferred until a new map/layout is drawn up and clarification is got from the school. The Members also insisted that the present walkways be retained. It was proposed by Councillor Kelly, seconded by Councillor Reilly and agreed to write to the Board of Management of the School when the new map is available.

The Mayor stated that the approval of the revised Plan by the Town Council was dependent on the Board of Management of the School and Public Opinion.

## Minutes of Special meeting held on Wednesday 12<sup>th</sup> January, 2011

The Deputy Mayor welcomed everyone to the meeting.

Mr. Cullen informed the Members that the Tuam Water Distribution and Main Drainage Scheme had reached a difficult stage, the sewers run through part of the Presentation College grounds. However an opportunity has arisen – the development of the O'Toole site which includes a road from Waterslade to Bishop Street. It is now proposed to relay the sewer, away from Presentation College, along the new road. The O'Toole development presents an opportunity to proceed with the construction of an inner relief road and include all services, Water, Gas ducting, Broadband ducting etc all in one go. The construction of the road is dependent on the relocation of the Tennis Court/Basketball Court.

Mr. Kelly presented a map showing a proposal to construct a new Tennis Court/ Basketball Court at the Palace Grounds. He also stated that funding for the all-weather pitch was still available. Replying to the Members Mr. Kelly said Galway County Council was not involved in discussions between the School and the Developer. The plan before the Board had been agreed in principle with the Board of Management of the School. He said the Developer is funding the relocation of the Tennis Court and the grant is available for the all weather pitch. Replying to Councillor Kelly he said the School would have a "licence" to use the Tennis Court. The all weather pitch, which would generate income, is a separate issue and would be subject to a planning application. If the proposal is adopted by the Town Council it will mean an investment of E500,000-00 in sport facilities in Tuam at very little cost to the taxpayer.

Councillor Cunniffe said there was a huge demand for recreational facilities in Tuam and the proposal should be made work in a way that wouldn't take away from the Park. Councillor Kitt was supportive of the proposal as long as a significant part of the park remained unaltered.

Replying to the Members Mr. Gilmore said Public ownership is valid – alternative hours at the swimming pool was achieved by negotiation, the proposed facilities would be under the control of the democratic process. Galway County Council are looking at the overall picture and trying to facilitate this development and are anxious to develop Tuam

as a retail hub for North Galway.

Following further discussion it was proposed by Councillor Ward, seconded and agreed that Mr. Kelly and the Members meet at the Palace Grounds on Monday 17<sup>th</sup> January, 2011 to view the area to be taken up by the Tennis Court and the All-weather pitch and clarify where they may be located in the park.

It was agreed to meet at the Palace Grounds at 4.15 p.m. on 17th January and then hold a

meeting in the Town Hall at approximately 5.30 p. m.

The Deputy Mayor thanked Mr. Kelly, Mr. Cullen and Mr. Gilmore for attending the meeting and answering the questions presented by the Members of the Board. He welcomed the provision of sport facilities in Tuam but the decision of the Town Council would be dependent on the agreement of the School and the People of Tuam.
